WAIVER AND RELEASE OF LIABILITY

In consideration of my child/ward being allowed to participate in any way in the Bay County Civic Arena (BCCA) programs and/or activities, the undersigned acknowledges and agrees that:

- 1) There is risk of injury to my child from participating in the activities involved in the BCCA may be significant, including the potential for permanent disability and death, and while rules, equipment, and personal discipline may reduce this risk, those risks do still exist; and,
- 2) For myself, my family and child, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF BAY COUNTY and its respective administrators, commissioners, elected officials, directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees") or others, and assume full responsibility for my child's participation; and,
- 3) I willingly agree to comply with the program's stated and customary terms and conditions for participation in its activities. If I have any concern regarding my child's readiness for participation in the activities, I will discontinue my child's participation in the activity immediately. If at any time I believe conditions to be unsafe, I will immediately remove my child from participation in the activity and bring such conditions to the attention of the nearest BCCA employee immediately; and,
- 3) I, for myself, my family, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE RELEASEES with respect to any and all injury, disability, death, loss or damage to person or property due to my child's involvement or participation in this program, whether arising from the negligence of the Releases or otherwise, to the fullest extent permitted by law; and
- 4) I, for myself, my family, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any and all liabilities due to my or my child's involvement or participation in this program, even if arising from their negligence to the fullest extent permitted by law; and
- 5) I have received a copy of the "Concussion Information Sheet;" and information from USA Hockey regarding supplement health insurance. I am free to participate in USA Hockey, but if I do not participate, I freely waive my rights to the benefits offered by USA Hockey.
- 6) I grant BCCA permission to take photographs and films including pictures of me, my child or ward. I consent to and authorize Bay County to use and reproduce photographs and films.
- 7) No inducements or promises have been made to me to secure my signature to this release and I have signed this release voluntarily without inducement.
