



Bob:

Attached are photos taken 06-22-2005 from my kayak along the North Branch of the Kawkawlin River. There are seven (7) photos total, labeled Fig. 1 – 7, showing the rusty old piping lying along the river banks. It is my assumption that this piping was originally used to pipe oil from the various small scavenger wells in the area to a central collection tank. If you can get the present owner of these wells to remove the piping, it will need to be done with care. They will need absorbent booms to contain any oil that might leak into the river. Their best bet would probably be to have Bierlein or a similar environmental cleanup company do the work to reduce the risk of a spill. Some expense will be involved, but at this point it's hard to feel sorry for any oil company, and they are ultimately responsible after all. If they won't cooperate willingly, maybe the DEQ will need to be brought in to encourage them to do the right thing. There must be many legal precedents assigning responsibility to the current owner for past sins (failure to cap abandoned wells, soil contamination, etc.).


I have also attached satellite photos with labeling to show you the approximate locations of the pipes pictured. There is also a pipe that spans the river next to the Wieland farm, but it was evidently submerged on 6-22, so I was not able to get a photo. At slack water, this pipe will not allow a boat to pass. It's probably visible now that the water has receded, unless it has been removed since last year.

Fig. 1 – Between Beaver Road and Wieland Farm, West bank.




Fig. 2 - Between Beaver Road and Wieland Farm, East bank.




Fig. 3 – Under Chip Road Bridge.




Fig. 6 - Just upstream from junction with South Branch.
