 WHEREAS, Several months ago, Bay County was made aware of the Bay-Arenac Behavioral Health Authority's interest in purchasing the property located at Madison & 4<sup>th</sup> Streets currently in use for parking for County staff and the public; and  
 WHEREAS, This site is near other properties in use for mental health programs and several community facilities including the County Building, the Jail, public housing and the Pere Marquette Depot site; and  
 WHEREAS, The sale of this property to BABHA would be a benefit to the downtown economy and would generate significant revenue to the County during challenging economic times; and  
 WHEREAS, Two property appraisals were obtained, one by the BABHA reflecting a property worth of \$422,000 and one by the County reflecting a property worth of \$460,000; and  
 WHEREAS, The County Executive has recommended the sale of the property to Bay-Arenac Behavioral Health Authority for \$439,237; and  
 WHEREAS, Under Michigan law, Commissioners serving on both the Board of Commissioners and the Bay-Arenac Behavioral Health Authority must abstain from negotiation or voting on this matter; Therefore, Be It  
 RESOLVED That the Bay County Board of Commissioners approves the sale of the County property located at Madison and 4<sup>th</sup> Streets to the Bay-Arenac Behavioral Health Authority for \$439,237.00; Be It Further  
 RESOLVED That the Chairman of the Board is authorized to execute the property sale documents on behalf of Bay County following legal review/approval; Be It Further  
 RESOLVED That budget adjustments, if required, are approved.

BY: WAYS AND MEANS COMMITTEE (1/6/09)

WHEREAS, Recently the 3<sup>rd</sup> Party Administration contract for Housing Rehabilitation Administration Services terminated mid-term and Bay County is faced with the immediate need to spend significant grant dollars or risk losing them; and

WHEREAS, There are time restrictions associated with the grant from Michigan State Housing Development Authority (MSHDA) and other areas of the state have already spent their funds and Bay County's funding may be withdrawn if not encumbered soon; and

WHEREAS, The Housing Rehabilitation program serves low income homeowners throughout Bay County (outside the City of Bay City) assisting in building code and housing stock improvements and there is a significant need in our community for these funds;

WHEREAS, Direct experience has shown that it is very important for project administration to occur locally (w/in Bay County) for multiple logistical reasons; and

WHEREAS, After careful review it is determined that BAH is the only local agency administering these same state grant funds; and

WHEREAS, The City of Bay City (Deputy City Manager) was contacted to explore their potential interest in administration services however because they use a different funding source (federal) which is currently undergoing a shift in priorities, they have declined to consider any additional activities at this time; and

WHEREAS, The BAH has a proven track record of efficient service and the latest monitoring report from MSHDA (Bay County's same grant officer) describes BAH as "exemplary" and "high performing"; and

WHEREAS, The Director of Environmental Affairs and Community Development proposes that the same previously Board approved contract for 3<sup>rd</sup> Party Administration be offered to BAH with the same terms for the Housing Rehabilitation program- except the contract is to terminate (not automatically renew) at the end of the 2008-2009 grant cycle and elimination of the match requirement as it is no longer required by MSHDA. Upon termination conditions and performance can be reevaluated; Therefore, Be It

RESOLVED That the Bay County Board of Commissioners approves the Agreement for Services with Bay Area Housing, Inc. and authorizes the Chairman of the Board to execute said Agreement on behalf of Bay County following legal review/approval; Be It Further

RESOLVED That budget adjustments as needed for the Housing Rehabilitation Program are approved.
