

The Bay Board of Canvassers met on Wednesday, November 8, 1989 for the purpose of canvassing the Special Election called for by the State of Michigan.

They proceeded to canvass the return sheets at 9:00 A.M. and continued until completed which was approximately 12:00 P.M.

After the canvass was completed the figures were reviewed by the Clerk and Deputy Clerk and it was discovered that there was a discrepancy in the sub-totals where the small cities of Auburn, Essexville, and Pinconning appear, as the clerk reviewed the unofficial totals and the official totals. The discrepancy was as listed below:

At that time the Clerk contacted the Chairman and asked that he return to check and review the figures of the unofficial tally and the official. Mrs. Doan stated that both tally clerks did not use calculators when adding the small city totals and that they both made the same error.

After the telephone conversations with the other board members and Mrs. Doan the Chairman was satisfied that the changes should be made and authorized the Clerk to change the figures to read correctly. Attached is an affidavit by Brezezinski.
