CANVASS OF GENERAL ELECTION

NOVEMBER 8-11, 13, AND 14, 2000

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, NOVEMBER 8, 2000, IN THE BAY COUNTY CLERK'S OFFICE IN THE BAY COUNTY BUILDING AND THEN IN CONFERENCE ROOM 100 AT THE BAY COUNTY LAW ENFORCEMENT CENTER. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE 2000 GENERAL ELECTION HELD ON TUESDAY, NOVEMBER 7, 2000. **CITY OF BAY CITY, WARD 1, PRECINCT 1**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED SEVEN SPOILED BALLOTS; THE LIST OF VOTERS IN THE POLL BOOK SHOWED FOUR SPOILED BALLOTS. THE TAPE WAS NOT LEGIBLE; THE MACHINE NEEDED NEW INK.

**CITY OF BAY CITY, WARD 1, PRECINCT 3**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 32 SPOILED BALLOTS; THE LIST OF VOTERS IN THE POLL BOOK SHOWED 29 SPOILED BALLOTS. THE MARKING OF SPOILED BALLOTS WAS INCORRECT IN SOME CASES.

**CITY OF BAY CITY, WARD 2, PRECINCT 1**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 20 SPOILED BALLOTS. THE LIST OF VOTERS INDICATED 18 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 2, PRECINCT 2**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 24 SPOILED BALLOTS; THE LIST OF VOTERS IN THE POLL BOOK SHOWED 22 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 2, PRECINCT 3**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 14 SPOILED BALLOTS; THE LIST OF VOTERS IN THE POLL BOOK SHOWED 13 SPOILED BALLOTS.

THE WRITE-IN CANDIDATES WERE NOT LISTED ON PAGE 54 OF THE POLL BOOK.

**CITY OF BAY CITY, WARD 3, PRECINCT 3**

THE WRITE-IN CANDIDATES WERE NOT LISTED ON PAGE 54 OF THE POLL BOOK. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 40 SPOILED BALLOTS; THE LIST OF VOTERS IN THE POLL BOOK SHOWED 35 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 4, PRECINCT 1**

SPOILED BALLOTS WERE NOT PROPERLY IDENTIFIED IN THE REMARKS SECTION IN THE LIST OF VOTERS IN THE POLL BOOK. BALLOTS WERE MARKED SPOILED BUT USED IN THE TALLY. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 29 SPOILED BALLOTS; THE LIST OF VOTERS INDICATED 28 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 4, PRECINCT 2**

THE CERTIFICATE OF ELECTION INSPECTORS INDICATED THREE SPOILED BALLOTS; THE LIST OF VOTERS INDICATED NINE SPOILED BALLOTS. SPOILED BALLOTS WERE

NOT PROPERLY IDENTIFIED IN THE REMARKS SECTION IN THE LIST OF VOTERS IN THE POLL BOOK.

THE BOARD RECESSED AT 4:30 P.M.

THE BOARD OF CANVASSERS RECONVENED THURSDAY, NOVEMBER 9, 2000, AT 9:00 A.M., IN CONFERENCE ROOM 100 AT THE BAY COUNTY LAW ENFORCEMENT CENTER. ALL MEMBERS PRESENT.

**CITY OF BAY CITY, WARD 4, PRECINCT 3**

AN UNREGISTERED VOTER WAS ALLOWED TO VOTE.

**CITY OF BAY CITY, WARD 5, PRECINCT 2**

SPOILED BALLOTS WERE NOT PROPERLY IDENTIFIED IN THE REMARKS SECTION IN THE LIST OF VOTERS IN THE POLL BOOK.

**CITY OF BAY CITY, WARD 5, PRECINCT 3-6**

BALLOTS SHOULD NOT BE RUN IN THE SAME SEQUENCE IN BOTH PRECINCTS (WARD 5, PRECINCTS 3-6 AND 3-7).

**CITY OF BAY CITY, WARD 6, PRECINCT 2**

WRITE-IN CANDIDATES WERE NOT RECORDED IN THE POLL BOOK ON PAGE 54. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 17 SPOILED BALLOTS; THE LIST OF VOTERS INDICATED 19 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 7, PRECINCT 1**

THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING OF THE BALLOT CONTAINER ON THE OPTICAL SCAN STATEMENT OF VOTES. THERE WAS NO SIGNATURE OF ARLENE JUHALA ON THE ELECTION INSPECTOR'S PREPARATION CERTIFICATE IN THE POLL BOOK.

THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES WAS MISSING. THE CLOSING CERTIFICATE OF ELECTION INSPECTORS INDICATED NINE SPOILED BALLOTS. THE BOARD OF CANVASSERS NOTED TEN SPOILED BALLOTS.

THE BOARD RECONVENED AT 1:00 P.M.

**CITY OF BAY CITY, WARD 8, PRECINCT 1**

SPOILED BALLOTS WERE NOT PROPERLY IDENTIFIED IN THE REMARKS SECTION IN THE LIST OF VOTERS IN THE POLL BOOK. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 18 SPOILED BALLOTS; THE LIST OF VOTERS INDICATED 12 SPOILED BALLOTS.

**CITY OF BAY CITY, WARD 9, PRECINCT 2**

THE INSPECTOR DID NOT SIGN THE ELECTION INSPECTOR'S PREPARATION CERTIFICATE FOR OPENING OF THE POLLS.

**CITY OF AUBURN**

THE POLL BOOK WAS NOT SIGNED BY THE ELECTION INSPECTORS.

INSPECTORS; ONE SIGNATURE WAS MISSING, AND THE BOARD OF CANVASSERS

THE ABSENTEE VOTER COUNT INDICATED 1,022 BALLOTS WERE ISSUED. THE  
BOARD OF CANVASSERS TALLY SHOWED 1,020 BALLOTS WERE ISSUED. BARBARA  
JAYNES DID NOT SIGN THE END OF THE TAPE.

### **CITY OF ESSEXVILLE, PRECINCT 1**

THE WRITE-IN CANDIDATES WERE NOT LISTED IN THE POLL BOOK AND THERE WAS  
NO TALLY FOR CANDIDATES.

### **CITY OF ESSEXVILLE, PRECINCT 2**

THE POLL BOOK SHOWED 15 SPOILED BALLOTS AND VOIDED BALLOTS; THE BOARD  
OF CANVASSERS' COUNT WAS 14 SPOILED BALLOTS.

### **BEAVER TOWNSHIP**

THE ELECTION INSPECTORS FAILED TO SIGN IN THE POLL BOOK PREPARATION  
CERTIFICATE. VOTER NO. 390, LINDA K. NESTLE, IN THE LIST OF VOTERS IN THE  
POLL BOOK, DID NOT HAVE A BALLOT NUMBER; THE BOARD OF CANVASSERS  
ASSUMED THAT THE BALLOT NUMBER WAS 417. VOTER NO. 1180, STEPHEN P.  
DECAUTER, IN THE LIST OF VOTERS IN THE POLL BOOK, DID NOT HAVE A BALLOT  
NUMBER; THE BOARD OF CANVASSERS ASSUMED THAT THE BALLOT NUMBER  
WAS 1212. ELEANOR SCHOENBINE DID NOT SIGN IN ON THE PREPARATION; SHE  
CAME IN AT NOON.

**BANGOR TOWNSHIP, PRECINCT 1**

THERE WERE NO SIGNATURES ON THE OATH OF OFFICE IN THE POLL BOOK.

THE BOARD ADJOURNED AT 11:30 A.M. FOR LUNCH.

THE BOARD RECONVENED AT 1:00 P.M.

**BANGOR TOWNSHIP, PRECINCT 1**

THE POLL BOOK SHOWED 52 SPOILED BALLOTS; THE BOARD OF CANVASSERS' COUNT WAS 50 SPOILED BALLOTS.

**BANGOR TOWNSHIP, PRECINCT 2**

THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES DID NOT LIST THE SEAL NUMBER ON THE BALLOT CONTAINER AND, WHEN THE SEAL NUMBER WAS AFFIXED, THE PERSON WHO SEALED THE CONTAINER AND THE WITNESS SHOULD HAVE SIGNED. THE MARKING WAS UNCLEAR IN THE LIST OF VOTERS IN THE POLL BOOK AS TO WHAT THE REPLACEMENT NUMBER WAS FOR THE DEFECTIVE OR SPOILED BALLOTS FOR VOTER NOS. 17 AND 18. ALSO, THERE WAS NO REPLACEMENT NUMBER FOR SPOILED BALLOT NO. 0883, VOTER NO. 456. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 37 SPOILED BALLOTS; THE LIST OF VOTERS INDICATED ONLY 3 SPOILED BALLOTS.

**BANGOR TOWNSHIP, PRECINCT 3**

THE CERTIFICATE OF ELECTION INSPECTORS AT THE CLOSE OF THE POLLS INDICATED 34 SPOILED BALLOTS; THE BOARD OF CANVASSERS SHOWED 41 SPOILED BALLOTS. THE WRITE-IN CANDIDATES WERE NOT LISTED IN THE POLL BOOK ON PAGE 54. THE SEAL NUMBER OF THE BALLOT CONTAINER WAS NOT SHOWN ON THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES.

**BANGOR TOWNSHIP, PRECINCT 4**

ON THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES, THERE WAS NO SEAL NUMBER AND NO SIGNATURE OF THE PERSON WHO SEALED NOR OF THE PERSON WHO VERIFIED THE SEALING OF THE BALLOT CONTAINER.

**BANGOR TOWNSHIP, PRECINCT 6**

THERE WERE NO WRITE-IN CANDIDATES IN THE POLL BOOK ON PAGE 54. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 43 SPOILED BALLOTS; THE BOARD OF CANVASSERS SHOWED 46 SPOILED BALLOTS.

**BANGOR TOWNSHIP, PRECINCT 7**

THERE WERE NO WRITE-IN CANDIDATES LISTED IN THE POLL BOOK ON PAGE 54. THE BOARD OF CANVASSERS DID NOT KNOW WHAT CONNECTION THERE WAS BETWEEN THE BALLOTS IN THE BACK OF THE POLL BOOK, NOS. 24, 23, AND 38.

THE SPOILED BALLOTS WERE NOT PROPERLY IDENTIFIED IN THE REMARKS SECTION IN THE LIST OF VOTERS IN THE POLL BOOK. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 65 SPOILED BALLOTS; THE BOARD OF CANVASSERS SHOWED 66 SPOILED BALLOTS.

THERE WERE NO WRITE-IN CANDIDATES LISTED IN THE POLL BOOK ON PAGE 54.

**HAMPTON TOWNSHIP, PRECINCT 3**

THE CERTIFICATE OF ELECTION INSPECTORS WAS NOT SIGNED BY THE MEMBER WHO SEALED CONTAINER NO. 773244. ALSO, THE SEALING WAS NOT VERIFIED. THE NUMBER OF SPOILED BALLOTS SHOWN WAS 28; THE BOARD OF CANVASSERS SHOWED 30 SPOILED BALLOTS.

**HAMPTON TOWNSHIP, PRECINCT 5**

THE POLL BOOK SHOWED DUPLICATE BALLOT NUMBERS AND REPLACEMENT NUMBERS. THE TOTAL NUMBER OF BALLOTS TO BE TABULATED WAS NOT IN THE POLL BOOK.

THE BOARD ADJOURNED AT 11:30 A.M. FOR LUNCH.

THE BOARD RECONVENED AT 12:45 P.M.

**MERRITT TOWNSHIP**

CAROL A. BUSH DID NOT SIGN THE TAPE AT THE CLOSE OF THE POLLS. THE TALLY FOR WRITE-IN CANDIDATES WAS NOT ENTERED IN THE POLL BOOK ON PAGE 54. THE TALLY WAS COMPLETED ON YELLOW PAD PAPER. THERE WAS NO SEAL NUMBER OR SIGNATURE ON THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES AS TO WHO SEALED AND WHO VERIFIED THE SEALING OF THE BALLOT CONTAINER. THE BOARD OF CANVASSERS HAD SEVERAL QUESTIONS CONCERNING THE TOTAL COUNT OF SPOILED BALLOTS IN THE POLL BOOK. CHAIRMAN LILA BRANLEE WAS TO CLARIFY.

THERE WAS NO SEAL NUMBER SHOWN ON THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES FOR THE BALLOT CONTAINER. SEAL NO. 773827 WAS TELEPHONED IN BY THE CLERK.

**MT. FOREST TOWNSHIP**

THE SEAL NUMBER WAS NOT INCLUDED ON THE OPTICAL SCAN/PBC 2100 STATEMENT OF VOTES. VOTER NUMBER 487, DONALD D. SLOVER, AND VOTER NUMBER 264, JENNIFER MULARZ, HAD NO BALLOT NUMBERS ON THE LIST OF VOTERS IN THE POLL BOOK.

**PINCONNING TOWNSHIP**

THE OPTICAL SCAN CLERK'S PREPARATION CERTIFICATE WAS NOT SIGNED BY THE TOWNSHIP CLERK. ANNETTE MOORE DID NOT SIGN THE CLOSING STATEMENT IN THE POLL BOOK. THE CERTIFICATE OF ELECTION INSPECTORS INDICATED 19 SPOILED BALLOTS; THE BOARD OF CANVASSERS SHOWED 20 SPOILED BALLOTS.

THE BOARD OF CANVASSERS WAS ADVISED BY COUNTY CLERK LINDA L. TOBER THAT ELECTION INSPECTORS RELEASED THE INCORRECT TUBULAR TAPE. THE ERROR WAS DISCOVERED WHEN THE BOARD WAS COMPARING FROM PRECINCTS WITH VOTES TABULATED BY CANVASSERS BOARD COMPARED WITH TUBULAR TAPES WITH THE CLERK'S REPORT.
