CANVASS OF ELECTION

JUNE 15, 2004

THE BAY COUNTY BOARD OF CANVASSERS MET ON TUESDAY, JUNE 15, 2004, IN THE CONFERENCE ROOM ON THE FOURTH FLOOR OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ANNUAL SCHOOL ELECTION HELD ON MONDAY, JUNE 14, 2004. THE FOLLOWING OBSERVATIONS WERE MADE BY THE BOARD MEMBERS DURING THE CANVASS OF VOTES. THE MEMBERS PRESENT WERE:

CHAIRMAN CHEVALIER CALLED THE BOARD OF CANVASSERS TO ORDER AT 10:20 A.M.

CANVASS OF THE VOTES COMMENCED:

PINCONNING TOWNSHIP, PRECINCT 1

THERE WAS A MISTAKE IN THE TOTAL FOR KAREN FOCO. INSTEAD OF 159, THE VOTES WERE 87; AND THE TOTAL WAS 164, INSTEAD OF 236. FOR CANDIDATE TOTH, THE TOTAL WAS 130, INSTEAD OF 232 BECAUSE PRECINCT 1 WAS LISTED AS 0 VOTES, BUT WAS ACTUALLY 112 VOTES. YAROS HAD 368 VOTES. THE TOTAL LISTED OF 209 VOTES WAS INCORRECT. THE TOTAL SHOULD HAVE BEEN 368 VOTES, BECAUSE PRECINCT 1 GAVE HIM 0 VOTES WHEN HE ACTUALLY HAD 159 VOTES.

CITY OF AUBURN

THERE WAS NO SEAL NUMBER FOR THE BALLOT STORAGE CONTAINER. THE SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND THE SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING WERE NOT ON THE CERTIFICATE OF ELECTION INSPECTORS.

CITY OF BAY CITY, WARD 2, PRECINCT 3

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

CITY OF BAY CITY, WARD 3, PRECINCT 1

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

CITY OF BAY CITY, WARD 3, PRECINCT 2

THERE WAS NO PROGRAM SEAL NUMBER ON THE CERTIFICATE OF ELECTION INSPECTORS.

CITY OF BAY CITY, WARD 5, PRECINCT 1

THE CERTIFICATE OF ELECTION INSPECTORS WAS INCOMPLETE AS TO THE NUMBER OF VOTERS AND THE NUMBER OF BALLOTS. NUMBER FIGURES WERE MISSING. THERE WAS NO PROGRAM SEAL NUMBER. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER. THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING.

CITY OF BAY CITY, WARD 5, PRECINCT 2

THE TAPE PRINT-OUT WAS NOT INCLUDED IN THE ENVELOPE. CANVASSERS USED THE CLERK'S TAPE. ONE MEMBER DID NOT SIGN THE STATEMENT OF OATH. THE FIGURES WERE NOT INCLUDED ON THE CERTIFICATE OF ELECTION INSPECTORS AS TO THE NUMBER OF VOTERS AND THE NUMBER OF BALLOTS.

CITY OF BAY CITY, WARD 5, PRECINCT 3

THE TAPE PRINT-OUT WAS NOT INCLUDED IN THE ENVELOPE. CANVASSERS USED THE CLERK'S TAPE.

CITY OF BAY CITY, WARD 6, PRECINCT 3

THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER. THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING.

CITY OF BAY CITY, WARD 7, PRECINCT 3

THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE

OF ELECTION INSPECTORS. THERE WERE NO REMARKS IN THE WRITE-IN VOTE SECTION OF THE STATEMENT OF VOTES.

CITY OF BAY CITY, WARD 8, PRECINCT 1

ONE MEMBER DID NOT SIGN THE ELECTION INSPECTOR'S PREPARATION CERTIFICATE.

CITY OF BAY CITY, WARD 8, PRECINCT 2

THE STATEMENT OF VOTES HAD NO INDICATION OF ANY WRITE-IN CANDIDATES.

CITY OF BAY CITY, WARD 8, PRECINCT 3

THE STATEMENT OF VOTES HAD NO INDICATION OF ANY WRITE-IN CANDIDATES.

CITY OF BAY CITY, WARD 9, PRECINCT 1

THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

CITY OF BAY CITY, WARD 9, PRECINCT 2

THERE WAS NO INDICATION OF THE WRITE-IN VOTES ON THE STATEMENT OF VOTES. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING. THE SEAL NUMBER OF THE CONTAINER WAS NOT LISTED ON THE CERTIFICATE OF ELECTION INSPECTORS.

CITY OF BAY CITY, A-V #1

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

CITY OF BAY CITY, A-V #3

THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE ABSENT VOTER COUNTING BOARD CERTIFICATE.

THE BALLOT CONTAINER WAS SECURED WITH SEAL NO. 773663. THE BOARD OF CANVASSERS RECESSED AT 12 NOON.

THE BOARD RECONVENED AT 1:15 P.M.

SEAL NO. 773663 WAS REMOVED FROM THE BALLOT CONTAINER.

BEAVER TOWNSHIP

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

FRANKENLUST TOWNSHIP

THERE WAS NO STATEMENT OF VOTES--SCHEDULE. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

HAMPTON TOWNSHIP, PRECINCT 3

THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

HAMPTON TOWNSHIP, PRECINCT 6

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

PORTSMOUTH TOWNSHIP, PRECINCT 1

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

PORTSMOUTH TOWNSHIP, PRECINCT 2

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

PORTSMOUTH TOWNSHIP, PRECINCT 3

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

WILLIAMS TOWNSHIP, PRECINCT 1

THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

WILLIAMS TOWNSHIP, PRECINCT 2

THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING ON THE CERTIFICATE OF ELECTION INSPECTORS.

WILLIAMS TOWNSHIP, PRECINCT 3

LINES 1 AND 2 OF THE CERTIFICATE OF ELECTION INSPECTORS WAS NOT COMPLETE.

CITY OF ESSEXVILLE, PRECINCT 1

THERE WAS NO DATE AT THE BOTTOM OF THE CERTIFICATE OF ELECTION INSPECTORS.

CITY OF ESSEXVILLE, PRECINCT 2

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES. THERE WAS NO STORAGE CONTAINER SEAL NUMBER ON THE CERTIFICATE OF ELECTION INSPECTORS. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE STORAGE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING.

HAMPTON TOWNSHIP, PRECINCT 1

THERE WERE TWO SIGNATURES MISSING ON THE ELECTION INSPECTOR'S PREPARATION CERTIFICATE. THERE WAS NO SIGNATURE OF THE MEMBER WHO SEALED THE CONTAINER AND NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING OF THE CONTAINER. THE STORAGE CONTAINER NUMBER AND THE DATE OF THE CERTIFICATE WERE NOT INCLUDED ON THE CERTIFICATE OF ELECTION INSPECTORS.

HAMPTON TOWNSHIP, PRECINCT 2

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

HAMPTON TOWNSHIP, PRECINCT 5

THERE WAS NO INDICATION OF THE WRITE-IN CANDIDATES ON THE STATEMENT OF VOTES.

BANGOR TOWNSHIP, PRECINCT 1

THE CHAIRPERSON WAS NOT SWORN IN; HOWEVER, SHE ADMINISTERED THE OATH OF OFFICE TO THE OTHER ELECTION INSPECTION OFFICERS.

BANGOR TOWNSHIP, PRECINCT 4

THE OATH OF OFFICE WAS NOT PROPERLY ADMINISTERED TO THE INSPECTOR OF ELECTIONS. SHE DID, HOWEVER, ADMINISTER THE OATH OF OFFICE TO OTHER ELECTION INSPECTORS. THE DATE OF THE ELECTION WAS NOT ENTERED ON THE CERTIFICATE OF ELECTION INSPECTORS.

BANGOR TOWNSHIP, PRECINCT 5

THE A-V VOTERS WERE NOT ENTERED IN THE POLL BOOK UNDER THE LIST OF VOTERS (THE COUNT STARTED WITH NUMBER 6). THE TALLY SHEET WAS NOT INCLUDED IN THE ENVELOPE.

BANGOR TOWNSHIP, PRECINCT 6

THERE WAS NO SIGNATURE OF THE PERSON ADMINISTERING THE OATH TO THREE ELECTION INSPECTORS. THERE WAS NO DATE ON WITNESS--ELECTION ON THE CERTIFICATE OF ELECTION INSPECTOR'S PAGE.

THE BAY COUNTY BOARD OF CANVASSERS COMPLETED THE CANVASS OF THE ANNUAL SCHOOL ELECTION AT 4:45 P.M. ON TUESDAY, JUNE 15, 2004.
