CANVASS OF AUGUST 8, 2006 ELECTION

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, AUGUST 9, 2006, IN BASEMENT ROOM #2 OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, AUGUST 8, 2006. THE FOLLOWING OBSERVATIONS WERE MADE BY THE BOARD MEMBERS DURING THE CANVASS OF VOTES. 
