CAMPAIGN FINANCE DATES

MICHIGAN DEPARTMENT OF STATE BUREAU OF ELECTIONS

Candidate Committees, Ballot Question Committees, Political Party Committees and local level PACs file Annual, Quarterly and campaign statements before and after primaries and elections.

PACs registered on the state level file four Campaign Statements a year on fixed dates. This includes Super PACs and Caucus Committees.

Committees that qualify for the \$1,000.00 Reporting Waiver are not required to file Annual Campaign Statements, campaign statements before and after primaries and elections or Quarterly Campaign Statements.

All committees are required to file Late Contribution Reports. See Appendix G of the committee manual for more information.

If your committee participates in a primary, a political party convention or an election not listed here, contact your filing official for applicable filing dates.

(*) An Annual Campaign Statement is not required of a committee that qualifies for the \$1,000.00 Reporting Waiver; that files a Post-Election Campaign Statement during December; PACs registered on the state level; an incumbent judge; or an officer whose salary is less than \$100.00 a month.

(**) Quarterly Campaign Statements are also owed by candidate, local PACs and political party committees that do not support or oppose a candidate who appears on the ballot in the calendar year.
