PROPOSAL 14-1

The purpose of the referendum is to approve or disapprove Public Act 408 of 2012, which dedicates a portion of use tax revenue to benefit metropolitan areas throughout this state.

LOCAL BALLOT PROPOSALS:

Garfield Township Fire Protection Millage Renewal Proposal

This proposal is for a renewal of 1 mill (\$1.00 per \$1,000.00 of taxable value) for the purpose of operating the Township Fire Dept. and maintaining the Fire Hall

Garfield Township Renewal of Extra Voted Millage for the Purchase of Fire Fighting Equipment

Renewal of ½ mill (\$.50 per \$1,000 of taxable value) to purchase fire fighting equipment.

Kawkawlin Township Fire Millage Increase Proposal

This proposal is for an increase of 1 mill for four years for the purpose of construction, maintenance and improvement of local public roads in Kawkawlin Township.

Charter Township of Monitor Road Millage Proposal
