NOTICE OF MEETING OF BOARD OF DETERMINATION

Notice Is Hereby Given to you as a person liable for an assessment that the Board of Determination, composed of Jim Bellor, Greg Blair, and Boyd Boettger will meet on

Wednesday, June 1, 2016, at 7:00 P.M.

at Frankenlust Township Hall, 2401 Delta Road, Bay City, Michigan, to hear all interested persons and evidence and to determine whether the drain is known as the Bay Valley Drain, as prayed for in the Petition to locate, establish and construct a drain to properly purify or improve the flow, or construct one or more relief drains, which may consist of new drain or extensions or consolidation with one or more existing drains or enlargements or connections to existing drains, or add one or more branches, to any portion thereof, which will properly drain the lands in said district, dated August 20, 2015, is necessary and conducive to the public health, convenience or welfare to properties and residents of Frankenlust Township in accordance with Sections 72 and 191 of Act No. 40, P.A. 1956, as amended, and for the protection of the public health of the following cities, villages and townships: Frankenlust

Location of Drain:

Commencing at the East quarter corner of Section 2, T13N, R4E, Frankenlust Township, Bay County, Michigan; thence S00°52'13"W 1122.00 feet along the East line of said Section; thence S89°07'47"E 64.00 feet perpendicular with the East line of said Section to the point of outlet into Squaconning Creek being the point of beginning of the proposed drain; thence S84°03'04"W 182.00 feet; thence N55°38'33"W 875.00 feet; thence N35°19'46"W 430.00 feet; thence N26°58'29"W 296.00 feet; thence N23°04'26"E 97.00 feet; thence N03°39'58"W 172.00 feet; thence N28°47'29"W 190.00 feet; thence N05°15'02"W 258.00 feet; thence N50°41'32"W 118.00 feet; thence N08°19'51"W 208.00 feet to point of ending. Total length of the proposed drain is 2,826.00 feet. OR AS FOUND NECESSARY UPON SURVEY.

Proceedings conducted at this public hearing will be subject to the provision of the Michigan Open Meetings Act and you are further notified that information regarding this meeting may be obtained from the County Drain Commissioner.
