CANVASS OF REGULAR ELECTION

MAY 3, 2005

THE BOARD OF CANVASSERS MET AT PORTSMOUTH TOWNSHIP HALL ON WEDNESDAY, MAY 4, 2005 AT 9:30 A. M. THE CANVASS COMMITTEE CONSISTED OF DAN CHEVALIER, WALT WOZNIAK, MATT LANCE, JAN PIERSON, DEE NIEDZINSKI, MARY IDA DOAN AND ARLENE STONE. DEE ANN DEBATS STAYED AT THE COUNTY BUILDING TO OPEN ENVELOPES AND PUT THEM IN ORDER. BOB WATKINS, BRAD AND GENEVA LOVE, FROM ES&S, WERE ALSO PRESENT. PRECINCT REPRESENTATIVES FROM PORTSMOUTH TOWNSHIP WERE GLORIA NUENKE, PCT. 1, DIANE WIECHEC AND MARY ANNE ADAMS, PCT. 2, AND MARILYN LEPPEK, PCT. 3. ALSO PRESENT WERE CYNTHIA LUCZAK, COUNTY CLERK, PATTI SHORKEY, DEPUTY CLERK AND JUDY BUKOWSKI, PORTSMOUTH TOWNSHIP CLERK.

THE REASON FOR MEETING AT PORTSMOUTH TOWNSHIP WAS BECAUSE OF THE HIGH NUMBER OF UNDER-VOTES. THE LARGE VOLUME OF UNDER-VOTES RAISED A FLAG DUE TO THE NUMBER OF UNDER-VOTES IN RELATION TO THE PROPOSAL. IT WAS DETERMINED THAT THERE WERE 585 UNDER-VOTES IN THE PORTSMOUTH TOWNSHIP ELECTION.

AT 9:45 A.M. THE THREE PRECINCT CONTAINERS WERE OPENED AND SEAL NUMBERS WERE VERIFIED. WE DIVIDED INTO THREE GROUPS. GROUP NUMBER ONE CONSISTED OF JAN PIERSON, GENEVA LOVE AND GLORIA NUENKE. THE OLD BAG SEAL NUMBER WAS 575625 AND THE OLD CONTAINER SEAL NUMBER WAS 575624. A TOTAL OF 643 VOTES WERE CAST WITH 238 UNDER-VOTES. THERE WAS ONE EXTRA BALLOT. IT WAS SUSPECTED THAT TWO BALLOTS WENT THROUGH AT THE SAME TIME (1 BLANK BALLOT). THEY FINISHED AT 11:00 A.M. THE BALLOT BAG WAS SEALED WITH NUMBER 896483 AND THE BALLOT CAN WAS SEALED WITH SEAL NUMBER 896425.

PRECINCT NUMBER TWO CONSISTED OF MATT LANCE, JUDY BUKOWSKI AND MARY ANN ADAMS. THE OLD BAG SEAL NUMBER WAS 575622 AND THE OLD CONTAINER NUMBER WAS 575648. A TOTAL OF 521 VOTES WERE CAST WITH 201 UNDER-VOTES. ALL TOTALS WERE CORRECT. THEY FINISHED COUNTING AT 10:50 A.M. THE BAG WAS SEALED WITH SEAL NUMBER 896435 AND THE CONTAINER WAS SEALED WITH SEAL NUMBER 986084.

PRECINCT NUMBER THREE CONSISTED OF DON CHEVALIER, WALT WOZNIAK AND MARILYN LEPPEK. THE OLD BAG SEAL NUMBER WAS 575650 AND THE OLD

CONTAINER NUMBER WAS 575649. A TOTAL OF 351 VOTES WERE CAST WITH 146 UNDER-VOTES. ON ELECTION DAY 3 BALLOTS WERE COUNTED TWICE BUT DID NOT EFFECT THE UNDER-VOTE TOTAL. THEY FINISHED COUNTING AT 10:35 A.M. (IT WAS NOTED THAT THE MACHINE CLOCK WAS OFF BY ONE HOUR). THE BAG WAS SEALED WITH SEAL NUMBER 986085 AND THE CONTAINER WAS SEALED WITH SEAL NUMBER 896481.

MARY IDA DOAN AND DELORES NIEDZINSKI WROTE DOWN TOTALS ON TALLY SHEETS FOR EACH PRECINCT. WALT WOZNIAK GAVE TOTALS FROM PRECINCTS THREE AND TWO AND DON CHEVALIER GAVE TOTALS FROM PRECINCT ONE.

WE FINISHED CHECKING THE PORTSMOUTH TOWNSHIP BALLOTS AND SEALING BAGS AND CONTAINERS AT 11:30 A.M. WEDNESDAY, MAY 4, 2005.

THE BAY COUNTY BOARD OF CANVASSERS RECONVENED ON WEDNESDAY, MAY 4, 2005 AT 1:30 P.M., IN ROOM #2 IN THE LOWER LEVEL OF THE BAY COUNTY BUILDING.
