THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, NOVEMBER 13, 1991 AT 9:30 a.m. FOR THE RECOUNT OF THE CITY OF ESSEXVILLE PRECINCT ONE, TWO AND THE A. V. PRECINCT FOR THE OFFICE OF MAYOR. BALLOTS WERE TO BE COUNTED FOR THE FOLLOWING CANDIDATES: WINIFRED GROBBEL AND BYRON SAVAGE AS CERTIFIED BY THE BOARD OF CANVASSERS FROM THE NOVEMBER 5, 1991 ODD YEAR GENERAL ELECTION. CHAIRMAN CHEVALIER EXPLAINED TO THE CANDIDATES HOW THE RECOUNT PROCEDURE WOULD BE CONDUCTED. THE MACHINES IN PRECINCT ONE WOULD BE COUNTED FIRST THEN WE WOULD PROCEED TO PRECINCT TWO WHICH WAS LOCATED AT THE METHODIST CHURCH, THEN RETURN TO THE CITY CLERKS OFFICE TO COUNT THE A. V. PRECINCT.

THE BOARD OF CANVASSERS CONCLUDED THEIR RECOUNT OF THE VOTING MACHINE PRECINCTS AT APPROXIMATELY 10:20 a.m. AT THIS TIME THE BOARD RETURNED TO THE CITY CLERKS OFFICE FOR THE REVIEW OF THE ABSENT VOTER PRECINCT.

THE COUNTING OF THE ABSENTEE BALLOTS BEGAN AT APPROXIMATELY 10:30 a.m.. CHAIRMAN CHEVALIER EXPLAIN ED TO THE GUESTS AND CANDIDATES THAT BALLOTS WERE ALLOWED TO BE CHALLENGED BUT NO BALLOTS WERE TO BE HANDLED BY ANYONE EXCEPT THE BOARD OF CANVASSERS.

CHAIRMAN CHEVALIER FIRST CHECKED THE BALLOT CAN TO MAKE SURE IT WAS PROPERLY SEALED AND THAT THE SEAL NUMBER COINCIDED WITH THE TALLY BOOK THAT BEING SEAL # 020093. ONCE THE SEAL WAS REMOVED BY CHAIRMAN CHEVALIER THE BALLOT BAG WAS CHECKED FOR PROPER SEAL AND WAS FOUND TO BE IN AGREEMENT WITH THE POLL BOOK, BEING SEAL NO. 5791.

UPON REMOVING THE BALLOTS FROM THE BALLOT BAG IT WAS NOTED THAT THERE WERE TWO ENVELOPES PROPERLY SEAL WITH A RED PAPER SEAL CONTAINING THE A. V. BALLOTS. ENVELOPES NO. 1 CONTAINED 65 BALLOTS AND ENVELOPE NO. 2 CONTAINED 66 BALLOTS WITH A TOTAL OF 131 BALLOTS WHICH WAS THE TOTAL ACCORDING TO THE POLL BOOK.

THE BALLOTS WERE PLACED ON THE TABEL AND COUNTED TO MAKE SURE THAT 131 BALLOTS WERE CONTAINED IN THE TWO ENVELOPES. CHAIRMAN CHEVALIER CALLED THE VOTES FOR EACH CANDIDATE AND MEMBER BRZEZINSKI PUT THEM IN TWO SEPERATE PILES.

AT THE COMPLETION OF THE ABSENT VOTER PRECINCT THE RESULTS WERE AS FOLLOWS: GROBBEL 61, SAVAGE 68 AND TWO BALLOTS THAT WERE NOT VOTED.

THE BALLOT BAG WAS RESEALED WITH SEAL # 5782 AT WHICH TIME CHAIRMAN CHEVALIER SHOW THE ABSENTEE COUNTING BOARD HOW TO PROPERLY INSERT THE SEAL ON THE BAG. THE BALLOT CAN WAS RESEALED WITH SEAL NO. 5794.

WITH THE FINAL NUMBERS CALCULATED THE RECOUNT TOTALS REMAINED THE SAME AS THE ORIGINAL CANVASS. THE COUNTY CLERK AND BOARD OF CANVASSERS DECLARED THAT WINIFRED GROBBEL WAS ELECTED MAYOR FOR THE CITY OF ESSEXVILLE. THE RECOUNT ADJOURNED AT 11:00 A.M.
