CANVASS OF NOVEMBER 2, 2010 ELECTION

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, NOVEMBER 3, 2010, AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, NOVEMBER 2, 2010. MEMBERS PRESENT WERE:

CHAIRMAN WOZNIAK CALLED THE BOARD OF CANVASSERS TO ORDER AT 1:00 P.M.

CANVASS OF THE VOTES COMMENCED:

ESSEXVILLE PRECINCT 1

PERSON ADMINISTERING THE OATH IN PREPARATION CERTIFICATE DID NOT SIGN THE CERTIFICATE OF OATH. OPTICAL SCAN DID NOT HAVE SIGNATURES OR CONTAINER NUMBER. ONLY ONE TAPE. PROPOSAL LANGUAGE NOT ATTACHED. 751 VOTES.

THE CITY OF ESSEXVILLE HAD A TIE ON THE RACE FOR CITY COMMISSIONER. JENNIFER GRADOWSKI RECEIVED 121 VOTES. BOTH MICHAEL LUTZ AND TIMOTHY NYKAMP RECEIVED 52 VOTES FOR A TIE. THE BOARD OF CANVASSERS VERIFIED THAT ALL VOTES WERE CORRECT AND THAT INFORMATION WAS RELAYED TO THE ESSEXVILLE CITY BOARD OF COMMISSIONERS.

TOTAL WRITE-IN COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. NO PHONE NUMBERS ON CLOSE OF POLLS CERTIFICATE. 250 VOTES.

BAY CITY, WARD 2, PRECINCT 2

ONLY ONE TAPE. TOTAL WRITE-IN COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES.

NOTED IN REMARKS SECTION OF POLL BOOK: JOSEPH LOREE AND LARRY LOREE BOTH CAME IN TO VOTE. JOSEPH'S NAME HAD ALREADY BEEN MARKED OFF IN ERROR AS IF HE HAD ALREADY COME IN TO VOTE. BOOK STATED LARRY SHOULD HAVE VOTED IN HAMPTON TOWNSHIP. BUT BOTH ARE LISTED AS SAME ADDRESS OF 1307 MCKINLEY STREET. JOSEPH'S VOTE WAS COUNTED AND LARRY'S WAS NOT ACCORDING TO COMMENT BOOK. 474 VOTES.

BAY CITY, WARD 2, PRECINCT 3

MARY JANE SKORNIA DID NOT SIGN ON CERTIFICATE OF ELECTION INSPECTORS SHEET THAT WERE PRESENT. TOTALS IN WRITE-IN COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. ONLY ONE TAPE. NO PHONE NUMBERS AT CLOSE OF POLLS CERTIFICATE. 420 VOTES.

BAY CITY, WARD 3, PRECINCT 1

SPOILED BALLOT NOT IDENTIFIED. TOTAL WRITE-IN COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. 198 VOTES.

BAY CITY, WARD 3, PRECINCT 2

TOTALS IN WRITE-IN COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. 247 VOTES.

NO SIGNATURES AT ALL IN CLERK'S PREPARATION CERTIFICATE ON OPTICAL SCAN SHEET IN POLL BOOK. SIGNATURES WERE ON THE ADDITIONAL OATHS OF ELECTION INSPECTORS SHEET. PHONE NUMBERS NOT LISTED FOR TWO INSPECTORS. 228 VOTES.

BAY CITY, WARD 4, PRECINCT 3

ONLY ONE TAPE. 371 VOTES.

TOTALS IN WRITE-INS COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. ONLY ONE TAPE. 432 VOTES.

TOTALS ON WRITE-INS COLUMN SHOULD HAVE INDICATED ZERO IN STATEMENT OF VOTES. NO PHONE NUMBER FOR DEBBIE ROGERS ON CERTIFICATE OF ELECTION INSPECTORS. SPOILED BALLOTS NOT MARKED PROPERLY. 341 VOTES.

BAY CITY, WARD 7, PRECINCT 3

RANDALL MCPEAK INCORRECTLY COMPLETED OATHS OF ELECTION INSPECTORS. HE SIGNED IN TWO PLACES. TOTALS ON WRITE-INS COLUMN SHOULD HAVE INDICTED ZERO IN STATEMENT OF VOTES. ONLY ONE SPOILED BALLOT FOUND IN POLL BOOK BUT CERTIFICATE SHOWS TWO. RANDY CALLED BACK AND SAID THAT HE WAS NEW AND SIGNED BOTH PLACES. HE OFFICIALLY WAS NOT SWORN IN. 355 VOTES.


