THIS DUPLICATE PROBLEM WAS NOT DOCUMENTED IN POLL BOOK REMARKS SECTION. BETTY CAME IN AND EXPLAINED THAT THE MAN CROSSED OVER TO HER PRECINCT BY MISTAKE FROM 5-2. TWO PRECINCTS USED ONE TABLE TO SIGN IN CAUSING THE CONFUSION.

US PRESIDENTIAL WRITE -INS NOT WRITTEN IN POLL BOOK, SIX SPOILED BALLOTS LISTED IN POLL BOOK, BUT ONLY FIVE ON OPTICAL SCAN SHEET. WHITE-OUT USED IN POLL BOOK, 608 VOTES.

SPOILED BALLOT NUMBER NOT PROPERLY PUT IN RIGHT COLUMN AND SPOILED NUMBER NOT CROSSED OFF. 631 VOTES.

**BANGOR TOWNSHIP, PRECINCT 3**

THEY LIST BRIAN MOORE ON WRITE-IN SHEET. NANCY MCFARLAND DID NOT SIGN OPTICAL SCAN SHEET OR TALLY TAPES. 850 VOTES.

**BANGOR TOWNSHIP, PRECINCT 4**

DIDN'T LIST THE PRESIDENTIAL CANDIDATES ON WRITE-IN SHEET AND DIDN'T LIST PARTY AFFILIATION ON DECLARED WRITE-IN SHEET FOR SUE ROSEBROCK. 720 VOTES.

**BANGOR TOWNSHIP, PRECINCT 5**

ON WRITE IN SHEET CINDY ROSEBROCK WAS LISTED INSTEAD OF SUE ROSEBROCK AND WE DIDN'T COUNT THAT VOTE. INSPECTOR DAWN BUBLITZ WAS NOT SWORN IN ON OPTICAL SCAN STATEMENT. 1021 VOTES.

**BANGOR TOWNSHIP, PRECINCT 6**

ON WRITE-IN SHEET COLLEN ROSEBROCK WAS LISTED AND NOT COUNTED.

**CANVASS OF NOVEMBER 4, 2008 ELECTION**

SHOULD HAVE BEEN SUE ROSEBROCK. EIGHT SPOILED BALLOTS LISTED IN POLL BOOK AND 10 WERE INDICATED ON OPTICAL SCAN SHEET. (REMARKS IN POLL BOOK SAY 2 WERE STUCK TOGETHER) 728 VOTES.

**BANGOR TOWNSHIP, PRECINCT 7**

PERSON ADMINISTERING OATH DID NOT SIGN CLERKS PREPARATION STATEMENT (MARILYN OSBOURN). 3 SPOILED BALLOTS LISTED IN POLL BOOK BUT FOUR WERE INDICATED ON OPTICAL SCAN SHEET. 286 VOTES.

2547 VOTES. DAWN BUBLITZ WAS NOT SWORN IN ON CLERKS PREPARATION STATEMENT AND DIDN'T SIGN CLOSE OF POLL BOOK. THREE WRITE-INS TAKEN OFF "WRITE-IN" SHEET FOR S. ROSEBROCK BECAUSE NAMES WERE INCORRECT (2 ROSECRANCE).

**BEAVER TOWNSHIP**

ONLY ONE TAPE. THEY DIDN'T DECLARE WRITE-INS FOR PRESIDENT ON OPTICAL SCAN STATEMENT. ACCORDING TO POLL BOOK, THERE WERE THREE SPOILED BALLOTS AND OPTICAL SCAN SHEET SHOWS TWO. TALLY TAPE SHOWS 1580 VOTES BUT POLL BOOK SHOWS 1575. IN THE REMARKS SECTION OF THE POLL BOOK, IT SHOWS FIVE BALLOTS JAMMED WHICH WOULD MAKE THE DIFFERENCE. 1575 VOTES.

**FRANKENLUST TOWNSHIP**

NO SIGNATURES FOR SEALING CONTAINER ON OPTICAL SCAN STATEMENT AND DONNA REICHARD DID NOT SIGN THE INSPECTION CLOSURE SHEET ON OPTICAL SCAN STATEMENT. 1414 VOTES.

PERSON ADMINISTERING OATH TO INSPECTORS DID NOT SIGN CLERK'S PREPARATION CERTIFICATE. OPTICAL SCAN INDICATES NO WRITE-IN CANDIDATES BUT THERE ARE TWO DECLARED WRITE-INS. ONLY ONE TAPE. 493 VOTES.

**HAMPTON TOWNSHIP PRECINCT 2**

DECLARED WRITE-INS WERE WRITTEN ON OPTICAL SCAN STATEMENT AS NONE WHEN THERE WERE DECLARED WRITE-INS. 691 VOTES.

GREGORY PETRIMOULX IS NOT LISTED IN THE SWEARING IN ON THE CLERK'S PREPARATION CERTIFICATE AND HIS SIGNATURE IS QUESTIONABLE? NO PRESIDENTIAL CANDIDATES WERE DECLARED ON WRITE-IN SECTION IN POLL BOOK. WE TALLIED 763 VOTES, BUT THE POLL BOOK SHOW 765. WE DON'T KNOW WHAT WOULD CAUSE THE DIFFERENCE. GREGORY PETRIMOULX DID NOT SIGN THE CLOSING OF THE POLL BOOK. 765 VOTES.
