BEAVER TOWNSHIP

THE HAND TALLY AND TAPE TOTALS SHOULD HAVE BEEN RECONCILED THE NIGHT OF THE ELECTION AND TOTALS CHECKED. THE PENMANSHIP ON THE WRITE-IN TOTALS WAS VERY POOR MAKING IT DIFFICULT TO READ THE NUMBERS. IT TOOK 2 ½ HOURS TO TALLY THE SHEETS, MARK AND CHECK TOTALS FOR ACCURACY. THE TALLY BOOK HAD TWO CANDIDATES WITH A CHANGE OF VOTES. COOK, MSU BOARD OF TRUSTEES HAD THREE LESS VOTES AND BORRELLO, JUDGE OF THE COURT OF APPEALS HAD FIVE MORE VOTES.

FRANKENLUST TOWNSHIP

OPTICAL SCAN STATEMENT OF VOTES DOES NOT CONTAIN STORAGE CONTAINER SEAL NUMBER. NO BALLOT PROPOSALS ATTACHED (BROUGHT IN SHEET). OPTICAL SCAN SUMMARY IS NOT COMPLETE. THE HAND TALLY AND TAPE TOTALS SHOULD HAVE BEEN RECONCILED THE NIGHT OF THE ELECTION AND TOTALS VERIFIED.

OPTICAL SCAN SUMMARY AND RECONCILED TALLY COMPLETED ON 11-14-06 BY AL APPOLD, TOWNSHIP CLERK AND DONNA REICHARD, PRECINCT CHAIRPERSON WHO APPEARED BEFORE THE BOARD TO EXPLAIN AND ASSIST WITH THE VOTE TALLY. THEY STATED THE VOTER TURNOUT WAS VERY HEAVY WHICH CAUSED THE PRECINCT TO RUN OUT OF BALLOTS RESULTING IN HAND TALLYING. FREELAND SCHOOL VOTERS' BALLOTS WERE HAND TALLIED. IN ADDITION, THE TOWNSHIP HAS A VERY LARGE NUMBER OF ABSENTEE VOTER BALLOTS WHICH WERE PROCESSED IN A SEPARATE TABULATOR. THESE THREE FACTORS CAUSED THREE RESULTS TALLIES THAT THE CLERK AND CHAIRPERSON RECONCILED AT THAT TIME.


