**CANVASS OF NOVEMBER 8, 2011 ELECTION**

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, NOVEMBER 9, 2011, AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, NOVEMBER 8, 2011. MEMBERS PRESENT WERE:

BOARD RECOUNTED THE TOTAL NUMBER OF BALLOTS RETURNED FROM AV PRECINCT 1-1 AND DISCOVERED A BALLOT WITH A RETURNED DATE BUT NO BALLOT NUMBER. THE BOARD DETERMINED THAT IT WAS AN ADDITIONAL BALLOT, CHANGING THE TOTAL COUNT TO 904 AND WARD 1-1 TO 168.

STATEMENT OF VOTES DID NOT FILL OUT SECTION ONE. BOARD DETERMINED THAT A BALLOT WAS NOT RECORDED AS COUNTED IN THE AV'S (HAD A DATE, NO BALLOT NUMBER). BOARD CHANGED TOTAL BALLOTS CAST TO 454.

BOARD ELIMINATED TWO WRITE-IN VOTES RECORDED DUE TO FIRST NAME BEING INCORRECT.

ONLY ONE TOTALS TAPE INCLUDED.

THE STATEMENT OF VOTES AS THE WITNESS FOR THE SEAL.

CANVASSERS CHEVALIER AND PIERSON CHECKED AND VERIFIED THE VOTE TALLIES.


