CANVASS OF MAY 4, 2010 ELECTION**

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, MAY 5, 2010, IN ROOM 2 AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, MAY 4, 2010. THE MEMBERS PRESENT WERE:

GIBSON TOWNSHIP-STANDISH STERLING SCHOOLS

A PROVISIONAL BALLOT WAS ISSUED TO ONE VOTER IN GIBSON TOWNSHIP BY THE ELECTION INSPECTORS ON ELECTION DAY. THE VOTER CONTENDS SHE HAD SUBMITTED A VOTER REGISTRATION TO THE BAY COUNTY CLERK'S OFFICE IN DECEMBER 2009 FOR FORWARDING TO THE GIBSON TOWNSHIP CLERK TO BE ADDED TO REGISTERED VOTER LIST FOR GIBSON TOWNSHIP. ON ELECTION DAY, THE VOTER WAS NOT ON THE PRECINCT LIST. THE TOWNSHIP CHANGED OVER TOWNSHIP CLERK'S IN GIBSON TOWNSHIP, AND CONSEQUENTLY, THE VOTER WAS NOT PUT IN THEIR REGISTERED VOTER LIST. ON ELECTION DAY, THE VOTER COMPLETED A NEW REGISTRATION FORM, SIGNED AN AFFIDAVIT AND WAS ABLE TO ANSWER "YES" TO THE QUESTIONS ON THE "4-STEP PROCEDURE" FORM USED TO DETERMINE ELIGIBILITY OF BALLOT ISSUANCE. THE ELECTION INSPECTORS ISSUED AN "ENVELOPE" BALLOT TO THE VOTER.

THE BOARD OF CANVASSERS EXAMINED THE "ENVELOPE BALLOT" MATERIAL SUBMITTED BY THE CURRENT TOWNSHIP CLERK AND DETERMINED THAT THE VOTER WAS ELIGIBLE TO VOTE IN THE ELECTION. THE VOTES WERE ADDED TO THE TOTALS.






