CANVASS OF ANNUAL SCHOOL ELECTIONS

JUNE 12-13, 2001

THE BAY COUNTY BOARD OF CANVASSERS MET ON TUESDAY, JUNE 12, 2001, IN THE CONFERENCE ROOM ON THE FOURTH FLOOR OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ANNUAL SCHOOL ELECTIONS HELD ON MONDAY, JUNE 11, 2001. CHAIRMAN NIEDZINSKI CALLED THE BOARD OF CANVASSERS TO ORDER AT 10:05 A.M.

CANVASS OF THE VOTES COMMENCED:

PINCONNING AREA SCHOOLS, PRECINCT 2

ON THE STATEMENT OF VOTES, THE TOTAL NUMBER OF VOTES WAS NOT LISTED ON PAGE 2.

PINCONNING AREA SCHOOLS, PRECINCT 3

ON THE STATEMENT OF VOTES, THE TOTAL NUMBER OF VOTERS WAS NOT LISTED ON PAGE 2. THE LAST PAGE WAS NOT COMPLETE: THE CERTIFICATE ITEMS WERE NOT CHECKED OFF, THE BALLOT BAG SEAL NUMBER AND THE BALLOT CONTAINER SEAL NUMBER WERE NOT LISTED, AND THE PERSONS WHO SEALED THE BALLOT BAG AND CONTAINER AND WHO VERIFIED THE SEALING WERE NOT LISTED. THE DATE OF WITNESSING THE CERTIFICATE OF ELECTION INSPECTORS WAS NOT ENTERED.

PINCONNING AREA SCHOOLS, PRECINCT 4

THERE WAS NO SIGNATURE OF THE PERSON WHO SEALED THE BAG OF THE BALLOT CONTAINER.

BANGOR TOWNSHIP, PRECINCT 2

ON PAGE 1, THE STATEMENT OF VOTES, THE WHOLE NUMBER OF VOTES WAS NOT LISTED. THE VOTES RECEIVED WERE NOT WRITTEN OUT IN WORDS.

BANGOR TOWNSHIP, PRECINCT 3

THE FRONT OF THE STATEMENT OF VOTES DID NOT LIST "TOTAL BALLOTS CAST." ON PAGE 1, STATEMENT OF VOTES, THE NUMBER OF VOTES WAS NOT LISTED. THE ELECTION INSPECTORS' CERTIFICATE WAS NOT COMPLETED. ON THE OATHS OF INSPECTORS OF ELECTION, BARCIA WAS NOT THE CHAIRPERSON AND THERE WERE NO SIGNATURES OF THE PERSONS ADMINISTERING THE OATHS. THE CERTIFICATE OF ELECTION INSPECTORS AT THE CLOSE OF POLLS WAS NOT COMPLETED.

BANGOR TOWNSHIP, PRECINCT 4

ON THE FRONT OF THE STATEMENT OF VOTES, "TOTAL BALLOTS CAST" WAS NOT COMPLETE. IN THE POLL BOOK, THE OATHS OF INSPECTORS OF ELECTION HAD NO SIGNATURE OF THE CHAIRPERSON. THE BOTTOM OF PAGE 9 DID NOT LIST THE TOTAL OF VOTERS.

BANGOR TOWNSHIP, PRECINCT 5

THE LIST OF VOTERS ON THE BOTTOM OF THE PAGE DID NOT LIST THE TOTAL OF VOTERS ON THIS PAGE.

BANGOR TOWNSHIP, PRECINCT 6

ON PAGE 1, THE STATEMENT OF VOTES WAS NOT ENTERED. THE ELECTION INSPECTORS' CERTIFICATE WAS NOT CHECKED AS TO DISPOSITION OF BALLOTS. IN THE POLL BOOK, THE LIST OF VOTERS DID NOT INDICATE TOTAL NUMBER OF VOTERS.

BANGOR TOWNSHIP, PRECINCT 8

ON THE STATEMENT OF VOTES ON THE LAST PAGE, THE ELECTION INSPECTORS' CERTIFICATE DID NOT LIST THE DISPOSITION OF BALLOTS.

THE POLL BOOK, LIST OF VOTERS, AT THE BOTTOM OF THE PAGE, WAS NOT COMPLETE AS TO TOTAL VOTERS ON PAGE.

THE BALLOT CONTAINER WAS SECURED WITH SEAL NO. 773504.
THE BOARD OF CANVASSERS RECESSED AT 12:10 P.M.

THE BOARD RECONVENED AT 1:15 P.M.
SEAL NO. 773504 WAS REMOVED FROM THE BALLOT CONTAINER.

IN THE POLL BOOK ON PAGE 15, THE TOTAL OF VOTERS ON PAGE WAS NOT TOTALED.

CITY OF BAY CITY, WARD 1, PRECINCT 1

THE STATEMENT OF VOTES, ELECTION INSPECTORS' CERTIFICATE, DID NOT INDICATE DISPOSITION OF BALLOTS. TERM LIMITS WERE NOT INDICATED ON THE TALLY SHEET OR STATEMENT OF VOTES.

CITY OF BAY CITY, WARD 1, PRECINCT 2

IN THE POLL BOOK, LIST OF VOTERS, ON PAGES 9 AND 10, THE TOTAL OF VOTERS WAS NOT LISTED.

CITY OF BAY CITY, WARD 1, PRECINCT 3

ON THE STATEMENT OF VOTES, ELECTION INSPECTORS' CERTIFICATE, THE DISPOSITION OF VOTES WAS NOT INDICATED. ROBERT B. CRITES ADMINISTERED THE OATH TO HIMSELF.

CITY OF BAY CITY, WARD 2, PRECINCT 1

ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES WAS NOT LISTED. THE OATHS OF INSPECTORS OF ELECTION INDICATED TWO CHAIRPERSONS. ON THE LIST OF VOTERS, PAGE 9, THE TOTAL OF VOTERS WAS NOT INDICATED.

CITY OF BAY CITY, WARD 2, PRECINCT 2

ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES FOR CANDIDATES WAS NOT CORRECT. TERMS OF OFFICE WERE NOT LISTED.

CITY OF BAY CITY, WARD 2, PRECINCT 3

ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES AND THE TOTAL VOTES WERE NOT LISTED. ON THE POLL BOOK, LIST OF VOTERS, "TOTAL OF VOTERS ON THIS PAGE" WAS INCORRECT.

CITY OF BAY CITY, WARD 3, PRECINCT 1

THE TALLY BOOK DID NOT GIVE A DESCRIPTION OF OFFICE. ON THE STATEMENT OF VOTES, THE TERM OF OFFICE WAS NOT INDICATED. IN THE POLL BOOK, PAGE 9, THE TOTAL OF VOTERS ON PAGE WAS NOT COMPLETED.

CITY OF BAY CITY, WARD 4, PRECINCT 1

THE TOTAL BALLOTS CAST WAS NOT COMPLETED ON THE FRONT OF THE STATEMENT OF VOTES. THE DISPOSITION OF BALLOTS WAS NOT INDICATED ON THE ELECTION INSPECTORS' CERTIFICATE ON THE BACK OF THE STATEMENT OF VOTES. IN THE POLL BOOK, PAGE 9, LIST OF VOTERS, THE TOTAL OF VOTERS WAS NOT COMPLETED.

CITY OF BAY CITY, WARD 4, PRECINCT 2

THE TERM OF OFFICE WAS INCORRECT FOR THE THREE-YEAR CANDIDATES. IN THE POLL BOOK, LIST OF VOTERS, PAGE 9, THE TOTAL OF VOTERS ON THE PAGE WAS NOT ENTERED.

CITY OF BAY CITY, WARD 5, PRECINCT 1

ON THE STATEMENT OF VOTES, PAGE 1, TOTAL VOTES WAS NOT ENTERED.

CITY OF BAY CITY, WARD 5, PRECINCT 2

ON THE STATEMENT OF VOTES, PAGE 1, TOTALS WERE INCORRECT.

CITY OF BAY CITY, WARD 5, PRECINCT 3

ON THE STATEMENT OF VOTES, PAGE 1, TOTALS WERE NOT ENTERED ON THE BACK PAGE. DISPOSITION OF BALLOTS WAS NOT INDICATED. IN THE POLL BOOK, PAGE 9, THE TOTAL OF VOTERS ON PAGE WAS NOT COMPLETED.

CITY OF BAY CITY, WARD 6, PRECINCT 1

IN THE POLL BOOK, LIST OF VOTERS, PAGE 9, THE TOTAL OF VOTERS WAS OMITTED FROM THE BOTTOM OF THE PAGE.

CITY OF BAY CITY, WARD 6, PRECINCT 2

IN THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES WAS NOT ENTERED.

CITY OF BAY CITY, WARD 6, PRECINCT 3

DISPOSITION OF BALLOTS WAS NOT INDICATED ON THE BACK PAGE OF THE STATEMENT OF VOTES. IN THE POLL BOOK, PAGE 9, THE TOTAL OF VOTERS WAS NOT ENTERED ON THE BOTTOM OF THE PAGE.

CITY OF BAY CITY, WARD 7, PRECINCT 1

THE TALLY SHEET DID NOT CONTAIN THE NAMES OF THE THREE-YEAR CANDIDATES STEUDLE AND HELMLING. THE BALLOT CANDIDATE VOTES WERE NOT TALLIED.

CITY OF BAY CITY, WARD 7, PRECINCT 2

THE STATEMENT OF VOTES ON PAGE 1 DID NOT LIST THE WHOLE NUMBER OF VOTES FOR CANDIDATES. THE TERM OF OFFICE WAS NOT INDICATED ON THE STATEMENT OF VOTES. IN THE POLL BOOK, ON PAGE 9, THE TOTAL OF VOTERS WAS NOT ENTERED.

CITY OF BAY CITY, WARD 7, PRECINCT 3

ON THE STATEMENT OF VOTES, PAGE 1, VOTES WERE NOT SEPARATED FOR FOUR-YEAR OR THREE-YEAR TERMS. THE TOTAL VOTES FOR THE FOUR-YEAR TERMS AND THE THREE-YEAR TERMS SHOULD BE SEPARATED AND ENTERED AS ONE TOTAL FOR FOUR-YEAR TERMS AND ONE TOTAL FOR THREE-YEAR TERMS. IN THE POLL BOOK, PAGE 10, THE TOTAL FOR NUMBER OF VOTERS ON PAGE WAS NOT ENTERED.

CITY OF BAY CITY, WARD 8, PRECINCT 1

THERE WAS NO BREAKDOWN OF VOTES FOR FOUR-YEAR-TERM OR THREE-YEAR-TERM CANDIDATES ON THE TALLY SHEET AND THE STATEMENT OF VOTES. THE STATEMENT OF VOTES DID NOT CONTAIN THE WHOLE NUMBER OF VOTES AND THE BREAKDOWN FOR EACH CANDIDATE. IN THE POLL BOOK, LIST OF VOTERS, PAGE 9, THE TOTAL OF VOTERS WAS NOT LISTED AT THE BOTTOM OF THE PAGE.

CITY OF BAY CITY, WARD 8, PRECINCT 2

THE TERM OF OFFICE WAS NOT INDICATED ON THE TALLY BOOK. IN THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES GIVEN FOR CANDIDATES WAS NOT ENTERED. DISPOSITION OF BALLOTS WAS NOT INDICATED. IN THE POLL BOOK, PAGE 9, TOTAL NUMBER OF VOTERS ON THE PAGE WAS NOT ENTERED.

CITY OF BAY CITY, WARD 8, PRECINCT 3

ON THE STATEMENT OF VOTES, THE TOTAL BALLOTS CAST DID NOT INDICATE A NUMBER. ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES GIVEN FOR CANDIDATES WAS NOT INDICATED. DISPOSITION OF BALLOTS WAS NOT CHECKED ON THE LAST PAGE OF THE STATEMENT OF VOTES. THE POLL BOOK, OATH OF INSPECTORS, WAS NOT SIGNED BY THE CHAIRPERSON. THE WRITE-IN LIST IN THE POLL BOOK INDICATED FOUR VOTES, BUT ONLY THREE SLASHES WERE MARKED.

CITY OF BAY CITY, WARD 9, PRECINCT 1

THE OPENING OATH OF INSPECTORS WAS NOT SIGNED BY THE CHAIRPERSON.

THE BALLOT CONTAINER WAS SECURED WITH SEAL NO. 895619.
THE BOARD RECESSED AT 5:00 P.M.

THE BOARD OF CANVASSERS RECONVENED WEDNESDAY, JUNE 13, 2001, AT 8:00 A.M.
SEAL NO. 895619 WAS REMOVED FROM THE BALLOT CONTAINER.

CITY OF BAY CITY, WARD 9, PRECINCT 1

ON THE STATEMENT OF VOTES, LAST PAGE, DISPOSITION OF BALLOTS WAS NOT INDICATED. IN THE POLL BOOK, THE OPENING OATH WAS NOT SIGNED BY THE CHAIRPERSON.

CITY OF BAY CITY, WARD 9, PRECINCT 2

ON THE TALLY SHEET, THE TERM OF OFFICE FOR CANDIDATES WAS CONFUSING. ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES WAS NOT FILLED IN FOR FOUR- OR THREE-YEAR TERMS. DISPOSITION OF BALLOTS WAS NOT INDICATED. MARY JANE SKORNIA WAS NOT SWORN IN (OPENING OATH) IN THE POLL BOOK. IN THE POLL BOOK, PAGE 9, TOTAL VOTERS ON PAGE WAS NOT FILLED IN.

CITY OF BAY CITY, WARD 9, PRECINCT 3

PLEASE REFER TO PAGE 58 REGARDING CONDITION OF WARD BUILDING. (CALLED CITY CLERK; CONDITION CORRECTED.)

CITY OF BAY CITY, A-V #1

ON THE STATEMENT OF VOTES, PAGE 1, WHOLE NUMBER OF VOTES GIVEN TO ALL (NOT EACH) CANDIDATES WAS NOT ENTERED WITH THE STATEMENT OR IN THE COLUMN.

CITY OF BAY CITY, A-V #2

ON THE STATEMENT OF VOTES, THE WHOLE NUMBER OF VOTES GIVEN TO ALL CANDIDATES (TOTAL) WAS NOT LISTED WITH THE LANGUAGE FOR FOUR-YEAR-TERM CANDIDATES OR THREE-YEAR-TERM CANDIDATES WITH THE STATEMENT OR IN THE COLUMN FOR FOUR-YEAR CANDIDATES. ON THE TALLY SHEET, THE TERM OF OFFICE WAS NOT LISTED FOR THE CANDIDATES.

CITY OF BAY CITY, A-V #3

ON THE STATEMENT OF VOTES, THE WHOLE NUMBER OF VOTES GIVEN TO CANDIDATES, THE TOTAL WAS NOT RECORDED. CANDIDATES FOR FOUR-YEAR TERMS SHOULD HAVE BEEN SEPARATED FROM CANDIDATES FOR THREE-YEAR TERMS. THE TOTAL SHOULD HAVE BEEN RECORDED IN THE COLUMN FOR THREE-YEAR CANDIDATES AND FOUR-YEAR CANDIDATES.

BEAVER TOWNSHIP

ON THE STATEMENT OF VOTES, PAGE 1, THE WHOLE NUMBER OF VOTES GIVEN TO CANDIDATES WAS NOT INCLUDED IN THE STATEMENT OR IN THE COLUMN. IN THE POLL BOOK, PAGE 11, THE TOTAL OF VOTERS WAS NOT INCLUDED AT THE BOTTOM OF THE PAGE.

FRANKENLUST TOWNSHIP

ON THE TALLY SHEET, THE TERM OF OFFICE FOR CANDIDATES WAS NOT LISTED ON PAGE 1. ON THE STATEMENT OF VOTES, THE TOTAL BALLOTS CAST WAS NOT NOTED. THE WHOLE NUMBER OF VOTES WAS NOT INCLUDED WITH THE STATEMENT OR COLUMN. THE VOTES RECEIVED WAS NOT WRITTEN IN WORDS. THERE WAS NO INDICATION OF TERM OF OFFICE FOR CANDIDATES. IN THE POLL BOOK, PAGES 9, 10, 11, 12, 13, AND 14, TOTAL VOTERS ON THE BOTTOM OF THE PAGES WAS NOT COMPLETED.

KAWKAWLIN TOWNSHIP, PRECINCT 1

THE TERM OF OFFICE FOR CANDIDATES WAS NOT LISTED. THE TOTAL NUMBER OF VOTES GIVEN TO ALL CANDIDATES WAS NOT INCLUDED (WHOLE NUMBER OF VOTES,

ETC.). THE CANDIDATES SHOULD HAVE BEEN SEPARATED BY TERM OF OFFICE. THE TOTAL NUMBER OF VOTERS BY PAGE WAS NOT WRITTEN IN ON THE BOTTOM OF EACH PAGE.

KAWKAWLIN TOWNSHIP, PRECINCT 2

CONGRATULATIONS! EXCELLENT PERFORMANCE.

HAMPTON TOWNSHIP, PRECINCT 3

THE TALLY FOR MARIE A. McFARLAND INDICATED MARKINGS OF 14 VOTES. THE EXTENSION TO THE TOTAL VOTES RECEIVED COLUMN INDICATED 19 VOTES. A SINGLE VOTE TOTAL SHOULD HAVE BEEN POSTED FOR FOUR-YEAR TERMS. IN THE POLL BOOK, THE BOTTOM OF THE LIST OF VOTERS DID NOT SHOW THE NUMBER OF VOTERS ON THE PAGE.

HAMPTON TOWNSHIP, PRECINCT 4

ON THE STATEMENT OF VOTES, THE WHOLE NUMBER OF VOTES GIVEN FOR CANDIDATES FOR FOUR-YEAR TERMS AND THREE-YEAR TERMS WAS NOT LISTED. IN THE POLL BOOK, PAGE 9, THE TOTAL OF VOTERS ON PAGE WAS NOT LISTED. THERE WAS NO SIGNATURE OF THE MEMBER WHO VERIFIED THE SEALING OF THE BALLOT BAG AND BALLOT CONTAINER. ON THE STATEMENT OF VOTES, THE TOTAL BALLOTS CAST WAS NOT ENTERED ON THE TOP OF THE FORM. WE SUGGEST ONE TOTAL SHOULD HAVE BEEN ENTERED FOR THE FOUR-YEAR-TERM CANDIDATES. IN THE POLL BOOK, THE TOTAL OF VOTERS ON PAGE 9 WAS NOT LISTED.

HAMPTON TOWNSHIP, A-V

THE CHAIRPERSON DID NOT SIGN THE OPENING OATH, NOR IS THE OPENING OATH COMPLETED.

MERRITT TOWNSHIP

THE TALLY SHEET DOES NOT INDICATE THE TERM OF OFFICE FOR THE CANDIDATES. ON THE STATEMENT OF VOTES, THE VOTES SHOULD HAVE BEEN LISTED SEPARATELY FOR FOUR-YEAR TERMS AND THREE-YEAR TERMS. THE ELECTION INSPECTORS' CERTIFICATE SHOULD HAVE INDICATED DISPOSITION OF BALLOTS. IN THE POLL BOOK, PAGE 9 AND PAGE 10 DID NOT INDICATE THE TOTAL OF VOTERS ON EACH PAGE.

THE BALLOT CONTAINER WAS SECURED WITH SEAL NO. 773505.
THE BOARD OF CANVASSERS RECESSED AT 12:10 P.M.

THE BOARD OF CANVASSERS RECONVENED AT 1:15 P.M.
SEAL NO. 773505 WAS REMOVED FROM THE BALLOT CONTAINER.

MONITOR TOWNSHIP, PRECINCT 2

ON THE STATEMENT OF VOTES, THE TOTAL BALLOTS CAST WAS NOT ENTERED ON THE COVER. THE WHOLE NUMBER OF VOTES WAS GIVEN FOR CANDIDATES—TOTAL—WAS NOT ENTERED FOR FOUR-YEAR-TERM AND THREE-YEAR-TERM CANDIDATES. THE FIGURES WERE NOT ADDED IN THE COLUMNS. IN THE POLL BOOK, THERE WAS NO SIGNATURE OF THE CHAIRPERSON FOR THE OPENING OATH. THE TOTAL OF VOTERS WAS NOT ENTERED AT THE BOTTOM OF PAGES 10 AND 11.

MONITOR TOWNSHIP, PRECINCT 3

ON THE STATEMENT OF VOTES, TOTAL OF BALLOTS CAST WAS NOT RECORDED. PAGE 1 OF STATEMENT SHOULD BE COMPLETED SHOWING TOTAL OF VOTES FOR CANDIDATES. POLL BOOK HAD NO SIGNATURE OF CINDY KOWALSKI BEING SWORN IN AS INSPECTOR.

MONITOR TOWNSHIP, PRECINCT 4

IN THE STATEMENT OF VOTES, THE VOTES FOR FOUR-YEAR CANDIDATES SHOULD HAVE BEEN TOTALED AND INCLUDED IN THE PRINTED STATEMENT. IN THE POLL BOOK, THE TOTAL OF VOTERS WAS NOT ENTERED ON PAGES 9 AND 10.

MONITOR TOWNSHIP, PRECINCT 5

THE TALLY SHEET DID NOT CONTAIN INFORMATION REGARDING THREE-YEAR-TERM CANDIDATES. IF NO VOTES WERE CAST, NAMES OF CANDIDATES SHOULD HAVE BEEN LISTED AND CONFIRMED WITH "NO VOTES." THE HASH MARKS SHOULD HAVE BEEN EXTENDED TO THE "TOTAL VOTES RECEIVED" COLUMN. THE WHOLE NUMBER OF VOTES GIVEN FOR CANDIDATES WAS NOT ENTERED FOR THE THREE-YEAR-TERM CANDIDATES. ENTRY SHOULD HAVE BEEN MADE FOR ONE TOTAL OF VOTES CAST FOR FOUR-YEAR-TERM CANDIDATES. THIS FIGURE SHOULD AGREE WITH THE TOTAL IN THE COLUMN AT THE RIGHT OF THE FORM. IN THE STATEMENT OF VOTES, PAGE 1, THE TOTALS WERE NOT WRITTEN IN FOR FOUR-YEAR-TERM AND THREE-YEAR-TERM CANDIDATES IN THE COLUMN AT THE RIGHT.

MONITOR A-V

IN THE STATEMENT OF VOTERS, THE WHOLE NUMBER OF VOTES GIVEN FOR CANDIDATES FOR FOUR-YEAR TERMS AND THREE-YEAR TERMS WAS NOT SHOWN AND SHOULD BE SEPARATE.

PORTSMOUTH TOWNSHIP, PRECINCT 1

THE TALLY BOOK ENTRIES DID NOT INDICATE WHICH CANDIDATES WERE RUNNING FOR THREE-YEAR TERMS OR FOUR-YEAR TERMS. THE SAME PROBLEM WAS FOUND IN THE POLL BOOK AND THE STATEMENT OF VOTES. THE WHOLE NUMBER OF VOTES CAST FOR CANDIDATES FOR FOUR-YEAR TERMS SHOULD HAVE BEEN LISTED SEPARATELY FROM VOTES CAST FOR THREE-YEAR-TERM CANDIDATES. THE FIGURES SHOULD HAVE BEEN LISTED IN COLUMNS AND TOTALED INDICATING THREE- AND FOUR-YEAR CANDIDATES. IN THE POLL BOOK, THE TOTALS AT THE BOTTOM OF PAGES 9, 10, AND 11 WERE NOT LISTED.

PORTSMOUTH TOWNSHIP, PRECINCT 2

THE STATEMENT OF VOTES, PAGE 1, WAS NOT COMPLETED PROPERLY. A SEPARATE VOTE TOTAL SHOULD HAVE BEEN LISTED FOR THREE-YEAR-TERM AND FOUR-YEAR-TERM CANDIDATES. THE ELECTION INSPECTORS' CERTIFICATE SHOULD HAVE INDICATED WHAT DISPOSITION WAS MADE OF BALLOTS.
