TOTAL VOTES 177. ONLY ONE TAPE. NO DECLARED WRITE-INS NOTED IN POLL BOOK. SPOILED BALLOT WAS MIS-WRITTEN IN THE POLL BOOK. (218 WAS THE CORRECT NUMBER OF THE SPOILED BALLOT)

ELECTION INSPECTORS PREPARATION CERTIFICATE WAS NOT CHECKED. TOTAL VOTES 225. ONLY ONE TAPE. NO DECLARED WRITE-INS NOTED IN POLL BOOK.

**BAY CITY, WARD 5, PRECINCT 2**

PERSON ADMINISTERING THE OATH OF OFFICE TO THE ELECTION INSPECTORS DID NOT SIGN THE CLERK'S PREPARATION CERTIFICATE. TOTAL VOTES 217. INSPECTORS DID NOT SIGN THE SHEET FOR THE SEAL NUMBERS FOR SEALING THE STORAGE CONTAINER AND THE TABULATOR. THE RESULTS TAPE WAS SIGNED BY 3 INSPECTORS, BUT ONLY 2 SIGNED THE OPTICAL SCAN SHEET. SHIRLEY BOUZA DID NOT SIGN THE SHEET CONTAINING THE VOTES. ONLY ONE TAPE. NO DECLARED WRITE-INS NOTED IN POLL BOOK.

(WHITE OUT USED IN POLL BOOK) DOROTHY CAME IN AND CHECK MARKS WERE COMPLETED AND NONE WAS WRITTEN IN DECLARED WRITE-INS SECTION OF POLL BOOK. IT WAS DETERMINED THAT THE VOTER FROM 8-2 (#299)(#314) BE COUNTED AS A SPOILED BALLOT. VOTER NUMBER 314 WAS ALLOWED TO BE COUNTED. HE SHOULD HAVE VOTED IN WARD 8, PRECINCT 2 (#299).


