CANVASS OF AUGUST 5, 2008
PRIMARY ELECTION**

TOTAL VOTES 80. ONLY ONE TAPE.

TOTAL VOTES 62. ONLY ONE TAPE. ON THE CERTIFICATE OF ELECTION INSPECTORS PAGE, THE BALLOT STORAGE CONTAINER NUMBER WAS MISSING. AILEEN CALLED THE CHAIRPERSON AND SHE WAS NOT HOME. AILEEN CALLED BACK AT 3:30 P.M., SHE WILL GET BACK TO US (ESTHER CONNERS?). SEAL NUMBER WAS MISSING AND IT WAS CALLED IN (#512743)

TOTAL VOTES 108. ONLY ONE TAPE. SPOILED BALLOTS NOT PROPERLY IDENTIFIED.

TOTAL VOTES 96. ONLY ONE TAPE.

TOTAL VOTES 513. ONLY ONE TAPE. NEED POLL TAPE. NO VOTER LIST. MATT CALLED DANA MUSCOTT AND TALKED TO PATTY. HE THEN TALKED TO DANA AND SHE WAS GOING TO SEND IT OVER TO THE COUNTY BUILDING. RECEIVED LIST OF VOTERS FROM DELIVERYMAN AT 1:55 P.M.

TOTAL VOTES 513. ONLY ONE TAPE. NEED POLL TAPE. NO PROBLEMS.

TOTAL VOTES 174. POLL BOOK INDICATES SIX SPOILED VOTES ON OPTICAL SCAN. SEVEN SPOILED VOTERS LISTED ON LIST OF VOTERS. ONE WAS NOT IDENTIFIED.

TOTAL VOTES 272. ONLY ONE TAPE. OPTICAL SCAN STATEMENT IN POLL BOOK SHOWS 29 SPOILED VOTES. LIST ONLY SHOWS 28. ONE WAS CROSSED OFF AND MIGHT HAVE BEEN COUNTED BY MISTAKE.

BANGOR TOWNSHIP, PRECINCT 2

TOTAL VOTES 196. ONLY ONE TAPE. SPOILED VOTE NOT PROPERLY MARKED. MARKING OF SPOILED BALLOTS IS CONFUSING. THEY SHOULD CHECK WITH CLERK FOR PROPER REMARKS. (THEY WERE MARKED AS SPOILED WITH NUMBER

AND ALSO REISSUED ALONG WITH ANOTHER NUMBER.

BANGOR TOWNSHIP, PRECINCT 3

TOTAL VOTES 194. ONLY ONE TAPE. CANVASSERS QUESTIONED THE USE OF STICKER NAMES IN POLL BOOK INSTEAD OF WRITTEN NAMES. MATT VERIFIED THE VALIDITY OF THEIR USE AND THE BOARD DETERMINED THEY WERE ALLOWED.

BANGOR TOWNSHIP, PRECINCT 4

TOTAL VOTES 180. ONLY ONE TAPE.

BANGOR TOWNSHIP, PRECINCT 5

TOTAL VOTES 336. ONLY ONE TAPE. SPOILED BALLOT MARKINGS ARE VERY CONFUSING. THEY INDICATED BALLOT NUMBER THAT WAS SPOILED AND ALSO PUT NUMBER OF RE-ISSUED BALLOT. THE TOTAL OF SPOILED BALLOTS WAS INDICATED AS 54 ON OPTICAL SCAN BUT LIST IN POLL BOOK SHOWS ONLY 50. MATT CALLED SHAWN DEPOS AND LEFT MESSAGE FOR HER TO CALL HIM BACK REGARDING THE ACTUAL NUMBER OF SPOILED BALLOTS. (STICKER NAMES ARE CHOPPED OFF. COULD NOT DETERMINE IF THEY WERE FIRST NAMES OR MIDDLE NAMES.) SHAWN CAME IN AND TOOK BOOK; COUNTED THREE TIMES. SHE COUNTED 51 EACH TIME.

BANGOR TOWNSHIP, PRECINCT 6

TOTAL VOTES 225. ONLY ONE TAPE. BARBARA GROMASKI WAS CALLED AND STATED MAXINE MUST HAVE COUNTED THE SPOILED BALLOTS INCORRECTLY. OPTICAL SCAN SAYS 32 AND LIST OF VOTERS SHOWS 31. BARB GROMASKI AND CAROL RAYMAK CAME IN AND RECOUNTED THE SPOILED BALLOTS. THEY DECIDED THE TOTAL SHOULD BE 31 SPOILED BALLOTS. THE BOARD APPROVED THEIR COUNT.

THE BOARD CALLED THE BUREAU OF ELECTIONS REGARDING THE CROPPED NAMES ON THE VOTER STICKERS IN THE POLL BOOK. SANDRA PRENGER, ELECTION SPECIALIST, VERIFIED THAT IT IS ACCEPTABLE IF SOME NAMES ARE CUT OFF A FEW LETTERS SHORT.

TOTAL VOTES 196. ONLY ONE TAPE. SCOTCH TAPE WAS USED ON THE TABULATOR TAPE AND IT WAS DIFFICULT TO READ.

TOTAL VOTES 810. ONLY ONE TAPE. NEED POLL TAPE.

TOTAL VOTES 410. ONLY ONE TAPE. SPOILED BALLOT NOT PROPERLY MARKED. OPTICAL SCAN SHEET SHOWS 73 SPOILED BALLOTS BUT 80 WERE COUNTED. KIM DAY AND KATY ROPER CAME IN AND THE PROBLEM WAS SOLVED. SEVEN SPOILED AV BALLOTS WERE NOT COUNTED. (KATY WAS NEW AND DID NOT KNOW TO ADD THEM IN.)

WRITE-IN VOTES FOR BRAD DUBAY WAS CHANGED FROM 172 TO 170 BECAUSE THEY WERE LISTED AS RANDY DUBAY AND BRIAN DUBAY. WRITE IN VOTES FOR JAMES HERBER WAS CHANGED FROM 163 TO 162 BECAUSE NAME WAS WRITTEN AS JIM HEREFORD.




