567 VOTES. ONLY 4 INSPECTORS SIGNED THE TAPE AND 7 INSPECTORS ORIGINALLY SIGNED. REASON NOT RECORDED IN REMARKS SECTION. WALT CALLED MICHELLE. THE 3 WHO DID NOT SIGN WILL BE IN TO SIGN ON THURSDAY.

361 VOTES. OPTICAL SCAN VOTES INDICATES 361 VOTES. THE BOARD COUNTED 359 VOTES. WRITE-INS NOT DECLARED ON STATEMENT OF VOTES. CHALLENGED VOTER SECTION OF POLL BOOK WAS NOT MARKED TO INDICATE NONE.

430 VOTES. OUR TAPE SHOWS THAT THERE WERE 430 VOTES BUT THE TOTALS FOR THE BALLOT LIST WAS 428. TWO PEOPLE MAY HAVE RETURNED THEIR BALLOTS ON ELECTION DAY AND NEVER MARKED ON THE LIST. NOTHING IS DOCUMENTED IN THE REMARKS SECTIONS. WALT CALLED TOM BOETFUER AND HE SAID TWO BALLOTS CAME IN ON THE DAY OF THE ELECTION AND WERE NOT MARKED. TOM SAID THAT THE TWO WERE ROBERT AND BETTY DAVIES. IT WAS

CHECKED BY JOHN AND FOUND THAT THEY WERE NOT MARKED AS RETURNED.


TALLY CLERKS BEGAN TO TOTAL THE VOTES.


