

**BAY COUNTY BOARD OF CANVASSERS  
RECOUNT OF SHERIFF'S RACE  
SEPTEMBER 10, 2012**

THE BAY COUNTY BOARD OF CANVASSERS MET ON MONDAY, SEPTEMBER 10, 2012 AT 8:10 A.M. IN THE PERSONNEL CONFERENCE ROOM, ON THE GROUND FLOOR OF BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CONDUCT A RECOUNT OF THE VOTES CAST FOR THE OFFICE OF SHERIFF IN THE PRIMARY ELECTION HELD AUGUST 7, 2012. SHERIFF CANDIDATES WERE ROBERT C. LEE, JOSHUA A. NOVAK AND JOHN E. MILLER.

PURSUANT TO PUBLIC ACT NO. 267 OF THE PUBLIC ACTS OF 1986, THE OPEN MEETING ACT, PROPER NOTICES HAVE BEEN POSTED AND THE CANDIDATES IN QUESTION HAVE BEEN NOTIFIED BY FIRST CLASS MAIL.

THE MEETING WAS CALLED TO ORDER BY WALTER WOZNIAK, JR., AT 8:10 A.M.

PORTSMOUTH TRUSTEE JAMES J. BANASZAK AND HENRY BRANDT HAD A DIFFERENCE OF 1 VOTE.

CHAIRMAN WOZNIAK INTRODUCED THE FOUR BOARD OF CANVASSERS MEMBERS, KEVIN LORENZ AS ALTERNATE, CYNTHIA LUCZAK, COUNTY CLERK, TALLY CLERKS ARLENE STONE, MARY IDA DOAN, AILEEN SEIFFERLY, AND JUDITH BUKOWSKI, PORTSMOUTH TWP. CLERK. ATTENDEES WERE INSTRUCTED NOT TO TOUCH THE BALLOTS/MATERIALS; HOW TO EXPRESS A CHALLENGE AND REMEDY TO COURT.

RECOUNT STARTED AT 8:20 A.M.

PORTSMOUTH 1 - SEAL #0019986 ON THE BLUE BAG WAS VERIFIED. THERE WERE 339 BALLOTS. SEAL #912996 ON THE TAN BAG WAS VERIFIED. SIX BALLOTS HAD STUBS ATTACHED.

DISCUSSION ON CALLING BRANDT AND BANASZAK OR CALLING ALL FIVE. MR. CHEVALIER STATED THE LAW REQUIRED THE CALLING OF ALL FIVE TRUSTEE CANDIDATES.

**CHALLENGE 1 - PORTSMOUTH 1:**

CROSSOVER IN US SENATOR RACE. PRECINCT 1. NO VOTES COUNTED FOR TRUSTEE.

ANOTHER SPOILED BALLOT CROSSOVER, NO VOTE CAST FOR BANASZAK OR BRANDT. NOT CHALLENGED BY CANDIDATE.

ANOTHER SPOILED BALLOT CROSSOVER, NO VOTE CAST FOR BANAZAK, ONLY 1 FOR BRANDT, CORRION AND VANDRIESSCHE.

ANOTHER SPOILED BALLOT CROSSOVER. VOTES FOR BRANT, CORRION, VANDRIESSCHE.

BUREAU OF ELECTIONS WAS CALLED BY LANCE FOR A VERBAL CONFIRMATION OF CROSSOVERS NOT COUNTED FOR PARTISAN, ONLY QUESTIONS COUNT FOR NON-PARTISAN. BALLOT CROSSOVER DOES NOT COUNT ANY OF THE VOTES ON THE BALLOT BUT THE NON-PARTISAN VOTE.

**CHALLENGE 2 - PORTSMOUTH 2:**

A MISCELLANEOUS MARK FOR REPUBLICAN DELEGATE AND GOOD MARKS FOR TRUSTEE CORRION, PETT, VANDRIESSCH AND BANASZAK. MAY HAVE CAUSED OVER VOTE ON TABULATOR AND DISREGARDED BALLOT BY EQUIPMENT. THE EYE OBSERVANCE MAY RESULT IN BOARD TO COUNT VOTES CAST FOR TRUSTEE.

**CHALLENGE 3 - PORTSMOUTH 2:**

VOTE FOR BRANDT IN QUESTION AS IN PENCIL AND NOT COMPLETELY FILLED OUT ENTIRE OVAL. NO VOTE COUNTED YET.

BLUE BAG SEALED WITH SEAL #0019983 VERIFIED. WHITE BAG SEALED WITH SEAL #512976 VERIFIED. 497 ON DOCUMENTS. 496 BALLOTS. ONE BALLOT DOCUMENTED

IN POLL BOOK.

CHALLENGE 2 AND 3 IN PORTSMOUTH PRECINCT 2 SO FAR.

MEMBER JANICE PIERSON ASKED TO BE EXCUSED FROM THIS PROCESS SINCE A CONFLICT OF INTEREST HAD BECOME EVIDENT BETWEEN MS. PIERSON AND MR. BOUDREAU. COURT PROCEEDINGS BETWEEN THE TWO PARTIES WERE PENDING.
