

**BAY COUNTY BOARD OF CANVASSERS
CANVASS OF AUGUST 4, 2015 ELECTION**

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, AUGUST 5, 2015, AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, AUGUST 4, 2015 WITHIN THE CITY OF BAY CITY PRECINCTS 6 AND 8 WHICH HAD A NUMBER OF CANDIDATES TO WARRANT PRIMARY ELECTIONS IN THE TWO (2) VOTING PRECINCTS OF BAY CITY. CHAIRMAN LANCE CALLED THE CANVASS BOARD SESSION TO ORDER AT 1:00 PM

THE MEETING WAS POSTED IN ACCORDANCE WITH THE OPEN MEETINGS ACT AND POSTED WITHIN THE REQUIRED STATUTORY TIME LIMITS.

MOTION: PIERSON MOVED TO APPROVE THE MINUTES PRESENTED FROM THE MAY 6, 2015 SESSION WHICH CANVASSED TWO (2) BALLOT PROPOSALS IN REGARD TO INCREASES IN THE STATE SALES TAX LICENSING. INCLUDED IN THE MOTION TO APPROVE, WAS AN AMENDMENT OF THE BANGOR TOWNSHIP TOTAL TALLY TO REFLECT TOTAL BALLOTS TALLIED AS 381 AND NOT 382 - A DIFFERENCE OF ONE VOTE AS DOCUMENTED. THE MOTION WAS SUPPORTED BY LORENTZ, AND CARRIED.

CITY OF BAY CITY, 6TH WARD

THE TOTAL VOTES CAST AT THE POLLS IN THE CITY OF BAY CITY, 6TH WARD WAS 66 REPRESENTING 16 VOTES FOR CANDIDATE ECKHART; 12 FOR BIGGS AND 37 FOR DAVIDSON. NO OTHER ISSUES TO REPORT IN THIS PRECINCT.

CITY OF BAY CITY, 8TH WARD

THE TOTAL VOTES CAST AT THE POLLS IN THE CITY OF BAY CITY, 8TH WARD WAS 218 REPRESENTING 164 VOTES FOR CANDIDATE CLEMENTS; 6 FOR CONDON; 14 FOR HINMAN AND 34 FOR SIBLEY. THERE WERE NO OTHER ISSUES TO REPORT.

CITY OF BAY CITY, AVCB-1 -


A TOTAL OF 284 BALLOTS WERE CAST IN ABSENTEE COUNTING BOARD 1 FOR THE CITY PRECINCTS INCLUDING WARD 6 AND 8 RESPECTIVELY. IN THE 6TH WARD , CANDIDATES BIGGS RECEIVED 25; DAVIDSON 105 AND ECKHART RECEIVED 13 VOTES. IN SAID AV BOARD FOR THE 8TH WARD, CANDIDATES CLEMENTS 93 VOTES, CONDON 0 (ZERO), HINMAN 26 AND SIBLEY 21 VOTES.

TOTALS WERE TALLIED AND VERIFIED FOR CORRECT TOTALS BY TALLY CLERKS. FOLLOWING THE VERIFICATION OF TOTALS, ALL CERTIFICATES OTHER REQUIRED DOCUMENTATION WAS SIGNED. ENVELOPES WERE SEALED. THERE WERE NO CHANGES IN RESULTS TO REPORT TO THE COUNTY CLERK.

THERE WERE NO PROVISIONAL BALLOT ISSUES TO MAKE DETERMINATION OF.

THE BAY COUNTY BOARD OF CANVASSERS COMPLETED THE CANVASS OF THE AUGUST 4, 2015 ELECTION AT 1:30 P.M. ON WEDNESDAY AUGUST 5, 2015.


