

**BAY COUNTY BOARD OF CANVASSERS

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, AUGUST 3, 2016, IN THE OFFICE OF THE BAY COUNTY CLERK, ON THE FIRST FLOOR OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE PRIMARY ELECTION HELD ON TUESDAY, AUGUST 2, 2016. CHAIRMAN LANCE CALLED THE BOARD OF CANVASSERS TO ORDER AT 1:10 P.M.

TOTAL VOTES: 376. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY, WARD 2, PRECINCT 1

TOTAL VOTES: 507. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY, WARD 3, PRECINCT 1

TOTAL VOTES: 295. CHAIRPERSON SWORE HERSELF IN - SHE SHOULD NOT HAVE. NOT ALL ELECTION INSPECTORS SIGNED THE CERTIFICATE OF ELECTION INSPECTORS AT THE CLOSE OF THE POLLS.

BAY CITY, WARD 4, PRECINCT 1

TOTAL VOTES: 280. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY, WARD 5, PRECINCT 1

TOTAL VOTES: 440. NOT ALL INSPECTORS SIGNED THE CERTIFICATE OF INSPECTORS ALTHOUGH THEY SIGNED EVERYWHERE ELSE.

BAY CITY, WARD 6, PRECINCT 1

TOTAL VOTES: 269. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY, WARD 7, PRECINCT 1

TOTAL VOTES: 325. THERE IS NO REMARK AS TO WHICH ELECTION INSPECTOR LEFT EARLY. BOARD REMINDS ELECTION INSPECTORS IF THEY LEAVE POLLS EARLY TO NOTE IN THE REMARK SECTION WHEN THEY LEFT.

BAY CITY, WARD 8, PRECINCT 1

TOTAL VOTES: 371. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY, WARD 9, PRECINCT 1

TOTAL VOTES: 359. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

BAY CITY BOARD 1 ABSENTEE VOTERS

TOTAL VOTES: 1053. THERE IS ONLY ONE TOTAL TAPE SHOULD HAVE BEEN DONE ON TWO TAPES.

BAY CITY BOARD 2 ABSENTEE VOTERS

TOTAL VOTES: 732. TOTAL TAPE INDICATED 732 BALLOTS TABULATED. COUNT OF VOTERS IN THE FILE INDICATED 724. CALLED THE CHAIRPERSON, KAREN JESKE, TO INQUIRE ABOUT THE DISCREPANCY. SHE INDICATED THAT EIGHT INVALID BALLOTS WERE RAN THROUGH THE TABULATOR AND REJECTED. HOWEVER, THE TABULATOR RECORDED THESE EIGHT INVALID BALLOTS IN THE TOTAL TABULATED. THIS SHOULD HAVE BEEN RECORDED IN THE REMARKS SECTION. THE BOARD ACCEPTED THIS EXPLANATION. ALSO ONLY ONE TOTALS TAPE.

CITY OF ESSEXVILLE PRECINCT 1

TOTAL VOTES: 243. WORKERS DID NOT INDICATE WHEN ELECTION INSPECTORS

LEFT. BOARD REMINDS WORKERS TO LEAVE A REMARK AS TO WHEN THEY LEFT.

CITY OF ESSEXVILLE PRECINCT 2

TOTAL VOTES: 265. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

TOTAL VOTES: 167. BOARD REMINDS ELECTION INSPECTORS THAT STAPLING OF ANYTHING IS PROHIBITED. WHITE OUT IS PROHIBITED, ALSO.

TOTAL VOTES: 317. PRECINCT WORKERS: FIVE SIGNED IN AT BEGINNING OF DAY, 4 SIGNED STATEMENT OF VOTERS, ONLY THREE SIGNED TAPES. REMARKS SHOULD REFLECT WHO LEFT AND WHEN.

TOTAL VOTES: 384. TABULATOR SHOWS 385, JAMMED.

FRASER TOWNSHIP PRECINCT 1

TOTAL VOTES: 459. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

GARFIELD TOWNSHIP

TOTAL VOTES: 350. VOTER COUNT 352 ON TABULATOR. INSPECTORS RAN FOUR BALLOTS INCLUDING TWO CROSS VOTED WHICH WERE TABULATED. PER BUREAU OF ELECTIONS THIS WAS ACCEPTED WITH REMARK. ON WRITE INS: DID NOT USE HASH MARKS SO, BOARD CANNOT VERIFY IF WRITE IN VOTES ARE VALID. BOARD DETERMINED THAT REPUBLICAN WRIT INS FOR CLERK AND TREASURER WERE DULY NOMINATED.

TOTAL VOTES: 147. BOARD ASKS NOT TO USE TAPE ON TABULATOR TAPES.

HAMPTON TOWNSHIP PRECINCT 1

TOTAL VOTES: 139. VOTES WERE 140 ON TABULATOR TAPE DUE TO A SPOILED BALLOT.

HAMPTON TOWNSHIP PRECINCT 2

TOTAL VOTES: 190. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

HAMPTON TOWNSHIP PRECINCT 3

TOTAL VOTES: 208. THERE WAS ONE SPOILED BALLOT THAT WAS TABULATED, HENCE THE 1 VOTE DIFFERENCE.

TOTAL VOTES: 204. THE BOARD FOUND NO MATTERS WHICH TO ADDRESS.

TOTAL VOTES: 137. THERE WERE 138 VOTERS, NUMBER 11, SPOILED BALLOT AND

DID NOT RETURN TO COMPLETE VOTE. HENCE THE POLL BOOK IS OFF BY ONE VOTE.

TOTAL VOTES: 1166. THE ACTUAL COUNTY WAS 21 OFF. ACTUAL VOTERS WERE 1166. WORKERS APPEARED TO HAVE RAN THE SPOILED BALLOTS THROUGH, CAUSING THE VOTES TO BE 1197. CALLED CLERKS OFFICE, DEPUTY, SUE, NOTED THAT THE ELECTION INSPECTORS DID NOT INDICATE WHICH BALLOTS HAD BEEN TURNED IN ON ELECTION DAY. CLERK SENT AN UPDATED LIST AND BOARD VERIFIED THE NUMBERS.

TOTAL VOTES: 247. DO NOT USE TAPE ON TOTALS TAPE.

KAWKAWLIN TOWNSHIP PRECINCT 2

TOTAL VOTE: 239. PER BOARD: DO NOT USE ADHESIVE TAPE TO ATTACH TOTALS TAPE. NO REMARK AS TO WHEN A POLL WORKER LEFT, MOLLY REINHARDT. CALLED CHAIRPERSON TO VERIFY THAT COMPUTER CRASHED, EXPLAINING WHY A DIFFERENT STYLE OF STATEMENT OF VOTES WAS INCLUDED. NO OTHER PROBLEMS REPORTED.
