

BAY COUNTY ELECTION COMMISSION

THE BAY COUNTY ELECTION COMMISSION MET ON WEDNESDAY, JUNE 20, 1990, IN THE OFFICE OF THE COUNTY CLERK. THE MEETING WAS CALLED TO ORDER AT 9:10 A.M. BY CLERK BARBARA ALBERTSON FOR THE PURPOSE OF REVIEWING ABSENTEE PRIMARY-PROOF BALLOT FOR THE AUGUST 7, 1990 ELECTION. THIS BALLOT HAD BEEN APPROVED BY THE ELECTIONS DIVISION ON JUNE 19, 1990. THE FOLLOWING ELECTION SCHEDULING COMMISSION MEMBERS WERE PRESENT.

COUNTY CLERK ALBERTSON ASKED FOR APPROVAL TO PROCEED WITH THE PRINTING OF THE BALLOT AS PRESENTED. ALSO, TO PROCEED WITH THE POSTING OF CANDIDATES AND SPENDING OF NECESSARY FUNDS FOR ELECTION EXPENSES.

BARBARA ALBERTSON EXPLAINED TO THE ELECTION COMMISSION MEMBERS THAT A PROOF BALLOT HAD BEEN SENT TO EVERY CANDIDATE ON THE BALLOT IN ORDER FOR THAT CANDIDATE TO APPROVE THE WAY HIS OR HER NAME WOULD APPEAR ON THE PRIMARY BALLOT. THE CANDIDATE WOULD ALSO CONFIRM THE DISTRICT OF WHICH HE OR SHE REPRESENTED.

DISCUSSION WAS HELD REGARDING THE DISTINCTION BETWEEN CANDIDATES SAMUEL P. GWIZDALA AND EUGENE F. GWIZDALA FOR THE 7TH DISTRICT COUNTY COMMISSION RACE, RICHARD LASKOWSKI FOR THE 7TH DISTRICT COMMISSIONER, AND RICHARD LASKOWSKI FOR ROAD COMMISSIONER. THE CLERK INFORMED THE ELECTION COMMISSION THAT THE ABOVE CANDIDATES COULD HAVE REQUESTED A DESIGNATION OF THEIR NAMES BUT THAT NONE OF THEM HAD DONE SO. THE EXAMPLE STATED - MR. EUGENE GWIZDALA COULD HAVE DESIGNATED "PRESENT COUNTY COMMISSIONER" BUT THAT HE CHOSE NOT TO REQUEST SUCH. ALSO THAT CANDIDATE SAMUEL P. GWIZDALA COULD HAVE REQUESTED THE BALLOT READ "PRESENT CITY COMMISSIONER" BUT ALSO CHOSE NOT TO DO SO. ED LEWANDOWSKI QUESTIONED WHETHER OR NOT A NICKNAME COULD BE USED AS A

DESIGNATION . CLERK ALBERTSON RESPONDED THAT A NICKNAME WAS NOT PERMITTED BUT THAT AN ADDRESS LISTED ON THE BALLOT MAY HAVE BEEN ANOTHER FORM FOR THE CANDIDATE TO CHOOSE.

THE CLERK WAS DIRECTED BY THE STATE ELECTIONS DIVISION TO INCLUDE A SENTENCE UNDER THE INSTRUCTIONS REGARDING PROCEDURE FOR A WRITE-IN CANDIDATE. THE CLERK WAS ASKED TO INCLUDE THE FOLLOWING SENTENCE TO THE BALLOT INSTRUCTION SECTION: "MAKE A CROSS OR A CHECK MARK IN THE SQUARE ABOVE NOT MORE THAN THE NUMBER OF NAMES FOR EACH OFFICE AS MAY BE INDICATED ON THE TITLE OF EACH OFFICE."

MOTION 1: CHAIRMAN DONER MOVED THAT THE ABSENTEE PROOF BALLOT FOR THE AUGUST 7, 1990 PRIMARY ELECTION BE APPROVED. EDWARD LEWANDOWSKI SUPPORTED THE MOTION AND IT WAS CARRIED BY A ROLL CALL VOTE OF 3 YEAS, 0 NAYS.

MOTION 2: EDWARD LEWANDOWSKI MOVED TO PROCEED WITH THE PAYING OF THE NECESSARY EXPENSES INCURRED FOR PROCESSING THE BALLOT. CHAIRMAN DONER SUPPORTED THE MOTION AND IT WAS PASSED BY A ROLL CALL VOTE OF 3 YEAS, 0 NAYS.

MOTION 3: EDWARD LEWANDOWSKI MOVED THAT THE ELECTION SCHEDULING COMMISSION MEETING BE RECESSED AT 9:15 A.M. CHAIRMAN DONER SUPPORTED THE MOTION AND THE SESSION WAS RECESSED BY PASSAGE OF A ROLL CALL VOTE-3 YEAS, 0 NAYS.
