THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, MARCH 9, 2016, IN THE OFFICE OF THE BAY COUNTY CLERK, ON THE FIRST FLOOR OF THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE PRESIDENTIAL PRIMARY ELECTION HELD ON TUESDAY, MARCH 8, 2016. TOTAL VOTES: 832. POLL BOOK INDICATES 833 VOTERS. TABULATOR SHEET INDICATED ONLY 832 BALLOTS WERE COUNTED. CALLED CHAIRPERSON, GERALDINE, WHO INDICATED THAT THEY WERE UNAWARE WHY THE TWO DID NOT MATCH; THEY THOUGHT THEY WERE BALANCED THROUGHOUT PER THEIR OWN CHECKS. CALLED THE TOWNSHIP CLARK WHO SAID SHE WAS UNAWARE THAT THERE WAS AN ISSUE. HER RECORDS INDICATE THAT 833 SHOULD BE THE CORRECT NUMBER OF VOTERS AND VOTES CAST. THE BOARD DECIDED TO ACCEPT THE TABULATOR SHEET AS PRESENTED WITH 832 VOTES AND PROCEEDED TO CALL THE RESULTS. IT APPEARS THAT THE COUNTING BOARD DID NOT RUN A BALLOT THROUGH THE TABULATOR. WE ARE UNABLE TO EXPLAIN WHY.

THE "UNOFFICIAL" TOTALS WITH NO OTHER CHANGES TO REPORT.


THE BOARD OF CANVASSERS ADJOURNED AT 4:00 P.M. ON MARCH 10, 2016.
