

CANVASS OF NOVEMBER 5, 2013 ELECTION

BAY COUNTY BOARD OF CANVASSERS

THE BAY COUNTY BOARD OF CANVASSERS MET ON WEDNESDAY, NOVEMBER 6, 2013, AT 1:00 P.M., AT THE BAY COUNTY BUILDING. THE PURPOSE OF THE MEETING WAS TO CANVASS THE VOTES CAST DURING THE ELECTION HELD ON TUESDAY, NOVEMBER 5, 2013. MEMBERS PRESENT WERE:

THE MEETING WAS POSTED IN ACCORDANCE WITH THE OPEN MEETINGS ACT.

MEMBERS PIERSON AND LORENTZ WERE SWORN IN AND SIGNED THE OATH OF OFFICE FOR NEW FOUR YEAR TERMS.

CHAIRMAN LANCE CALLED THE BOARD OF CANVASSERS TO ORDER AT 1:00 P.M.

CANVASS OF THE VOTES COMMENCED:

AUBURN, PRECINCT 1

432 VOTES. A LIST OF VOTERS WAS NOT INCLUDED IN THE CANVASSER PACKET/ENVELOPE. THE CITY OF AUBURN WAS CONTACTED WITH THAT REQUEST. THE CHAIRPERSON DELIVERED THE LIST TO THE CANVASS BOARD AT 3:15 P.M.

BAY CITY, WARD 1, PRECINCT 1

126 VOTES. NO PROBLEMS WERE NOTED.

BAY CITY, WARD 3, PRECINCT 1

168 VOTES. NO PROBLEMS WERE NOTED.

BAY CITY, WARD 5, PRECINCT 1

109 VOTES. THE CANVASS BOARD REQUESTED DUANE NAFFERIN TO APPEAR. HE SIGNED IN THE WRONG AREA IN THE POLL BOOK AND IT APPEARS HE SWORE HIMSELF IN. WHEN HE APPEARED HE INDICATED HE UNDERSTOOD THAT HE MAY NOT SWEAR HIMSELF IN AND WILL DO IT CORRECTLY IN THE FUTURE. WRITE-INS WERE NOT DOCUMENTED PROPERLY IN THE WRITE-IN SECTION. PRECINCT INSPECTORS DID NOT TALLY THE VOTE, JUST DOCUMENTED THE TOTAL. ALSO, ONLY NAME DOCUMENTED IN POLL BOOK WAS MJ GORNEY. THE

CANVASS OF NOVEMBER 5, 2013 ELECTION

CANVASS BOARD FOUND IT ODD THERE WERE NOT VARIOUS SPELLINGS OF THE WRITE IN CANDIDATE'S NAME. ALL TWENTY WRITE IN VOTERS MAY HAVE WRITTEN THE SAME THING, BUT PAST EXPERIENCE INFERS OTHERWISE. NONETHELESS, THE WRITE IN TALLY SECTION WAS NOT COMPLETED PROPERLY.

BAY CITY, WARD 7, PRECINCT 1

127 VOTES. THE SIGNATURE OF THE PERSON WHO SWORE IN THE ELECTION WORKERS WAS MISSING. K. LORENTZ CALLED RANDY MCPHIL WHO APPEARED BEFORE THE BOARD TO AFFIX THE MISSING SIGNATURE.

BAY CITY, WARD 9, PRECINCT 1

36 VOTES. THE CANVASS BOARD NOTED THAT THIS PRECINCT DID A GOOD JOB.

BAY CITY AVCB 1

868 VOTES. NO PROBLEMS WERE NOTED. TOTALS TAPES REFLECT GENERATION TIME AFTER 12 A.M. (MIDNIGHT).

ESSEXVILLE PRECINCT 1

174 VOTES. 123 ABSENTEE BALLOTS AND 51 BALLOTS VOTED AT POLLS FOR A TOTAL OF 174. POLL BOOK SHOWS 176 A DIFFERENCE OF 2 VOTES. THE CHAIRPERSON WAS CALLED AND A MESSAGE LEFT ON HER PHONE QUESTIONING THE DIFFERENCE. CHAIRPERSON APPEARED AT COUNTY CLERK'S OFFICE AND EXPLAINED SHE THOUGHT THE EBP WOULD AUTOMATICALLY RECORD THE TWO (2) SPOILED BALLOTS PROCESSED BUT THAT WAS NOT THE CASE AND RESULTED IN A 2 VOTE DIFFERENTIAL AS JUSTIFIED.

ESSEXVILLE PRECINCT 2

201 VOTES. NO PROBLEMS NOTED.

PINCONNING CITY

52 VOTES. NO PROBLEMS NOTED.

FRANKENLUST TOWNSHIP, PCT. 2

16 VOTES CASE ON A BALLOT THAT PRESENTED ONLY A FREELAND SCHOOL BALLOT QUESTION. NO PROBLEMS NOTED.

TOTALS WERE TALLIED AND VERIFIED. ALL CERTIFICATES AND DOCUMENTATION WAS SIGNED. ENVELOPES WERE SEALED WITH THE EXCEPTION OF ESSEXVILLE PRECINCT 1 WAITING ON CHAIRPERSON EXPLANATION.

THE BAY COUNTY BOARD OF CANVASSERS COMPLETED THE CANVASS OF THE NOVEMBER 5, 2013 ELECTION AT 4 P.M. ON WEDNESDAY, NOVEMBER 6, 2013 BY UNANIMOUS VOTE.
