ONE VOTER WAS NOT REMOVED FROM LIST. HENCE, VOTER ROLL SHOWS +1 COMPARED TO TABULATOR. WRITE-IN SHEET- DO NOT USE WHITE OUT ON A LEGAL DOCUMENT.

369 VOTES. WRITE-IN SHEET DID NOT SHOW JUERS AS 0 VOTES.

556 VOTES. VOTER LIST INDICATES 560 VOTERS, YET TABULATOR INDICATES 556. NO REMARKS. CALLED CHAIRPERSON. SHE INDICATED THAT VOTERS LISTED AS "SPOILED" SHOULD NOT HAVE BEEN COUNTED. FOUR SUCH INSTANCES WERE DISCARDED, BRINGING THE TALLY SHEET AND POLL BOOK INTO AGREEMENT. WRITE-IN SHEET NOT TALLIED WITH HASH MARKS.
