

BAY COUNTY ELECTION COMMISSION

THE BAY COUNTY ELECTION COMMISSION MET ON TUESDAY, SEPTEMBER 27, 1988 IN THE OFFICE OF THE COUNTY CLERK. THE MEETING WAS CALLED TO ORDER BY THE CLERK AT 3:00 P.M. WITH THE FOLLOWING MEMBERS PRESENT: EDWARD LEWANDOWSKI

THE CLERK PRESENTED A PROOF BALLOT TO THE COMMISSION AND STATED THAT SHE HAD BEEN TO LANSING, MICHIGAN ON FRIDAY, SEPTEMBER 23, 1988, AND THAT THERE WERE MINOR CHANGES TO BE MADE. ONE, BEING THE WORD "STATE" TO APPEAR ON ALL STATE PROPOSALS AND THE OTHER BEING THE TERM ENDING, BY DATE, AND STIPULATED IN THE JUDICIAL SECTION OF THE BALLOT.

THE CLERK HAD CONSULTED WITH THE PRINTER AND ALL THE CORRECTIONS HAD BEEN MADE BY MONDAY, SEPTEMBER 26, 1988, AND TWO PROOF BALLOTS WERE MAILED TO THE STATE ELECTIONS DIVISION THAT AFTERNOON.

ON TUESDAY, PRIOR TO THE 3:00 MEETING, THE COUNTY CLERK RECEIVED A TELEPHONE CALL FROM THE ELECTIONS DIVISION STATING THAT ALL CHANGES HAD BEEN MADE PROPERLY AND TO PROCEED WITH THE NECESSARY STEPS OF PREPARING FOR THE ELECTION.

THE COUNTY CLERK SHOWED THE COMMISSION THE CHANGES THAT WERE MADE AND ALSO PRESENTED A CERTIFIED LIST OF CANDIDATES THAT WOULD BE APPEARING ON THE NOVEMBER 8TH, 1988 GENERAL ELECTION BALLOT.

UPON REVIEWING THE NAMES ON THE BALLOT, COMMISSIONER LEWANDOWSKI MOVED THAT THE BALLOT BE APPROVED BY THE BAY COUNTY ELECTION COMMISSION AND THAT THE BAY COUNTY CLERK PROCEED IN SENDING PROOF BALLOTS TO ALL CANDIDATES. ALL CANDIDATES WERE CERTIFIED BY THE CLERK AND EACH CANDIDATE HAD 48 HOURS TO RETURN THE CERTIFICATION OF THEIR NAME TO THE COUNTY CLERK. SUPPORTED BY JUDGE PAUL DONER.

COMMISSIONER LEWANDOWSKI ALSO MOVED THAT THE CLERK BE AUTHORIZED TO PROCEED WITH ANY OTHER STEPS NECESSARY IN THE SETTING OF THE VOTING MACHINES, RETURN SHEETS, ETC. IN ADDITION, THE CLERK BE AUTHORIZED TO INCUR ANY EXPENSES NECESSARY TO CONDUCT THE ELECTION.
