Bay Medical Care Facility Millage Proposal

Kawkawlin Township Road Millage Increase Proposal

This proposal is for an increase of 1 mill for four years for the purpose of construction, maintenance and improvement of local public roads in Kawkawlin Township.

Merritt Township Road Millage Renewal Proposal

This proposal will renew of previously voted millage for the purpose of maintaining and improving public road in Merritt Township for a period of five years.

Delta College Millage Renewal Proposal

This proposal will permit Delta College to continue the current levy of millage for college purposes by renewing the College's authority to levy 0.4864 mill previously approved by the voters, which will expire after the 2015 levy.
