Proposals:

The following is a summary of the six (6) state and local proposals which shall be considered on the November 4, 2014 ballot:

STATEWIDE PROPOSALS

PROPOSAL 14-1

Referendum of Public Act 520 of 2012, establishing a hunting season for wolves and authorizing annual wolf hunting seasons.

PROPOSAL 14-2

Referendum of Public Act 21 of 2013, granting the Natural Resources Commission the power to designate wolves and certain other animals as game without legislative action.

COUNTYWIDE PROPOSALS

BAY COUNTY HISTORICAL PRESERVATION MILLAGE RENEWAL PROPOSAL

This proposal is for the purpose of renewing the property tax limitation by .1 mill for historic preservation work within Bay County for 20 years.

BAY METROPOLITAN TRANSPORTATION AUTHORITY MILLAGE RENEWAL

This proposal is for the purpose of renewing the property tax limitation by .75 mill to be used exclusively for the continued operation of the Bay Metropolitan Transportation Authority for 5 years.

BAY COUNTY LIBRARY SYSTEM MILLAGE RENEWAL PROPOSAL

This proposal is for the purpose of renewing the property tax limitation by 1 mill for funding general operations, programs and services of the Bay County Library System for 6 years.

LOCAL PROPOSALS

KAWKAWLIN TOWNSHIP ROAD MILLAGE PROPOSAL

This proposal is for the purpose of increasing the property tax limitation by 1 mill for the purpose of construction, maintenance and improvement of local public roads in Kawkawlin Township for four years.

Electors who wish to vote in the General Election must be registered to vote no later than **5:00 pm on Monday, October 6, 2014** in accordance with Michigan Compiled Law 168.498.

At any of the Secretary of State Branch offices during normal business hours.

At the specified agency for clients receiving services through the Michigan Office of Human Services, the Department of Community Health, Michigan Jobs Commissioner and some offices of the Commission for the Blind. At the Military Recruitment offices for persons enlisting in the Armed Forces.

By Mail:

By obtaining and completing a Mail-In Voter Registration Application and forwarding it to the election officials as directed on the application by the close of registration deadline, **Monday, October 6, 2014 at 5:00 p.m.** Mail-in voter registration applications may be obtained from the

County Clerk or at www.michigan.gov/sos.
