FREELAND COMMUNITY SCHOOLS MILLAGE RENEWAL PROPOSAL

The millage proposal is for renewal of 1 mill (\$1.00 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property in Freeland Community School District, Saginaw, Midland and Bay Counties, Michigan, for a period of 6 years to continue to provide for a sinking fund for the construction or repair of school buildings and all other purposes authorized by law.
