**BALLOT PROPOSALS TO APPEAR ON THE NOVEMBER 3, 2020 BALLOT**

- 1) **Delta College Millage Renewal and Restoration-** Passage of this proposal will permit Delta College to levy 0.50 mill for operating purposes for 8 years. Of the 0.50 mill, 0.4864 represents a renewal of the authorization previously approved by the electors in 2012, which will expire after the 2023 levy and 0.0136 mill represents a restoration of the portion of prior millage authority, which will expired in 1999, which was reduced by application of the Headlee Amendment. This will generate \$5,705,218 in the first year of levy.
- 2) **Medical Care Facility Millage Proposal -** This is a new property tax limitation of 1 mill representing (\$1 per \$1,000 of taxable value) for a period of nine (9) years, inclusive of 2020-2029 for operation, maintenance and capital cost for the Bay Medical Care Facility. This will generate \$2,812,091.09 in the first year.
- 3) **Library Millage Renewal Proposal -** This will authorize and amount not to exceed 1.75 mills (\$1.75 on each \$1,000 of taxable value) which is a renewal Of the previously authorized millage that expired in 2019, for a period of six (6) years, 2020-2025 inclusive for operating, maintaining and equipping the Bay County Library System. This will generate \$5,155,768.81 in first year.
- 4) **Kawkawlin Adult Use Marihuana Proposal (Kawkawlin Township)**  
Shall the Township of Kawkawlin adopt a measure to provide for the licensing of an unlimited number of recreational based marihuana businesses, which will nullify the Township Board's prior decision to opt-out of recreational based Marihuana businesses as allowed under MCL 333.27956 (1) , also known as The Michigan Regulation and Taxation of Marihuana Act?
- 5) **Williams Charter Township Road Repair and Reconsideration Millage Proposal -** Shall the 15 mill tax limitation on general ad valorem taxes be increased by a new millage of 2.0 mills (\$1.00 for \$1,000 of taxable value) for a period of ten (10) years 1/1/2021-1/1/2031 for the purpose of road repair and reconstruction. This should raise \$383,568,99 in the first year.
